| 19 | Seventy-Six Thousand, Seven Hundred Fifty Dollars (\$76,750.00).   |
| 20 | Section 2. Funds for this purchase are allocated in the Public Works Special Project Account No.               |
| 21 | 205409-72300-S40B623.  |
| 22 | Section 3. Because The Lilly Company is the only distributor for the GO-4 Interceptor Cart meeting             |
| 23 | the Departments specifications, the Board of Directors declares it is impractical and unfeasible to submit     |
| 24 | this purchase to competitive bids.   |
| 25 | Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or        |
| 26 | word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or          |
| 27 | adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and     |
| 28 | effect as if the portion so declared or adjudged invalid or unconstitutional were not originally a part of the |
| 29 | ordinance.   |
| 30 | Section 5. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with       |
