16	WHEREAS, on January 23, 2017, the City of Little Rock issued Request for Proposals No. 17114
17	for an organization or individual to design, implement, and present in-person instruction of a
18	comprehensive Cultural Diversity and Cultural Competency Training Program, specific to a law
19	enforcement community, for the Little Rock Police Department and;
20	WHEREAS, on February 28, 2017, a Selection Committee appointed by the City Manager found the
21	proposal of Global Perspectives Consulting, LLC, to be qualified and in the best interests of the City, and;
22	WHEREAS, the City desires to retain and engage Global Perspectives Consulting, LLC, to create,
23	provide and conduct a comprehensive Cultural Diversity and Cultural Competency Training Program for
24	the Little Rock Police Department, and;
25	WHEREAS, Global Perspectives Consulting, LLC, represents that it is capable of and desirous of
26	performing these services; and
27	WHEREAS, on April 4, 2017, the Board approved Resolution No. 14,537 to execute a Professional
28	Services Agreement with Global Perspectives Consulting, LLC, in the amount of Fifty-Eight Thousand
29	Dollars (\$58,000.00), to provide Cultural Diversity and Cultural Competency Training; and
30	WHEREAS, the Little Rock Police Department requests an amendment to the existing agreement by

adding a Cultural Intelligence Basic Assessment for a cost of Eight Thousand, Eight Hundred Dollars (\$8,800.00), bringing the total annual cost to Sixty-One Thousand, Eight Hundred Seventy Dollars (\$61,870.00), and

7	Program for the Little Rock Police Department in an annual additional amount of Eight Thousand, Eight			
8	Hundred Dollars (\$8,800.00), with an annual total amount not to exceed Sixty-One Thousand, Eight			
9	Hundred Seventy Dollars (\$61,870.00), plus any applicable taxes.			
10	Section 2. This is the second year of a three (3)-year agreement, but in no event will the Agreement			
11	extend beyond December 31, 2019.			
12	Section 3. Funding for these services will be available from Account No. 105220-63390.			
13	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or			
14	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or			
15	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and			
16	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the			
17	resolution.			
18	Section 5. Repealer. All resolutions, bylaws, and other matters inconsistent with this resolution are			
19	19 hereby repealed to the extent of such inconsistency.	hereby repealed to the extent of such inconsistency.
