SYNOPSIS	Ten (10) residential structures are in a severely dilapidated, deteriorated, burned condition, creating a public safety issue and causing a negative environmental impact on the residential neighborhoods in which it is located. All notices have been mailed and responses received, in accordance with Arkansas State Law.		
FISCAL IMPACT	The estimated cost to demolish and remove these structures is \$95,000. The charge for these Ten (10) structures will be charged to the demolition account 108359.		
RECOMMENDATION	Approval of the ordinance.		
BACKGROUND	These structures have been documented as severely dilapidated and now constitute a public safety hazard. These structures have been abandoned by the owners, or the owners have requested the city to demolish them. They are fire damaged or deteriorated to a level of being unsafe and dangerous.
