12	and 57 Vista Pointe Subdivision in the City of Little Rock, Pulaski County, Arkansas: From		
13	R-2, Single Family District, to R-4, Two Family District (Mountain Vista Drive and Summit		
14	View Drive).		
15	Section 2. The map referred to in Chapter 36 of the Code of Ordinances of the City of Little Rock and		
16	Designated District Map be and is hereby amended to the extent and in the respects necessary to affect and		
17	designate the change provided for in Section 1 hereof.		
18	Section 3. The ordinance shall take effect and be in full force from and after its passage and approval.		
19	Section 4. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or		
20	word of this ordinance is declared or adjudged to be invalid or unconstitutional, such declaration or		
21	adjudication shall not affect the remaining portions of the ordinance which shall remain in full force and		
22	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the		
23	ordinance.

25	the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
