10	WHEREAS, Bids were solicited for improvements for Brookside Drive Sidewalk Improvements,
11	Project No. 16-4-SW-2, Bid No. 538; and,
12	WHEREAS, Escamilla Excavating, LLC, was the lowest responsive, responsible bid meeting
13	specifications.
14	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY
15	OF LITTLE ROCK, ARKANSAS:
16	Section 1. The City Manager is hereby authorized to execute an agreement with Escamilla Excavating,
17	LLC, for Brookside Drive Sidewalks Improvements in an amount not to exceed One Hundred Twenty-Six
18	Thousand, Eight Hundred Fifty-Eight Dollars (\$126,858.00), which is the base bid amount of One Hundred
19	Five Thousand, Seven Hundred Fifteen Dollars (\$105,715.00), plus 20% contingencies.
20	Section 2. Funding for this project is from the 3/8-Cent Capital Improvement Sales and Compensating
21	Use Tax Funds and the 2018 Capital Improvement Bonds for Streets and Drainage as authorized by
22	Resolution No. 14,803 (June 19, 2018).
23	Section 3. Severability. In the event any title, section, paragraph, item, sentence, clause, phrase, or
24	word of this resolution is declared or adjudged to be invalid or unconstitutional, such declaration or
25	adjudication shall not affect the remaining portions of the resolution which shall remain in full force and
26	effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of the
27	resolution.
28	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same, that are inconsistent with
29	the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
