1	Section 5. That the map referred to in Chapter 36 of the Code of		
2	Ordinances of the City of Little Rock, Arkansas, and designated district map be and is hereby amended		
3	to the extent and in the respects necessary to affect and designate the change provided for in Section 1		
4	hereof.		
5	Section 6. Severability. In the event any title, section, paragraph, item,		
5	sentence, clause, phrase, or word of this ordinance is declared or adjudged to be invalid or		
7	unconstitutional, such declaration or adjudication shall not effect the remaining portions of the ordinance		
3	which shall remain in full force and effect as if the portion so declared or adjudged invalid or		
9	unconstitutional was not originally a part of the ordinance.

1	the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
