10	WHEREAS, pursuant to Section 8. C. of Little Rock, Ark., Resolution No. 13,343 (July 11, 2011), the	
11	Board of Directors directed proceeds be set aside in an amount up to Three Million Dollars (\$3,000,000.00) for	
12	Expansion and Improvement of Facilities to enhance the Arkansas State Fairgrounds; provided the Fair remain	
13	at its current location within the City on Roosevelt Road; and,	
14	WHEREAS, an initial appropriation of Ninety Eight Thousand, Seven Hundred Dollars (\$98,700.00) was	
15	made for improvements to Barton Coliseum in Little Rock, Ark., Resolution No. 13,577 (October 1, 2012); and	
16	WHEREAS, an appropriation for Ninety Five Thousand Dollars (\$95,000.00) was made to assist with	
17	additional improvement costs to the Coliseum and Administration Building on the Fairgrounds in Little Rock	
18	Ark., Resolution No. 13,874 (April 15, 2014); and,	
19	WHEREAS, in Little Rock, Ark., Resolution No. 14,770 (April 17, 2018) the City Manager and other City	
20	employees were authorized to execute an agreement between the City and the Arkansas State Fair Associatio	
21	("ASFA"), also referred to as the Arkansas Livestock Show Association, to formalize the contractual terms of	
22	the relationship; and,	
23	WHEREAS, the Arkansas Livestock Show Association has announced its intention to keep the fair in Little	
24	Rock for the foreseeable future; and,	
25	WHEREAS, the General Manager of the Arkansas State Fair Association has requested funding to	
26	reimburse the Arkansas Livestock Show Association in an amount of Three Hundred Ninety One Thousand	
27	Three Hundred Thirty-Eight Dollars and 86/100 Dollars (\$391,338.86) for capital improvements on the mai	
28	gate, perimeter fencing, and south parking lot.	
29	NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF	
30	LITTLE ROCK, ARKANSAS:	
31	Section 1. The sum of Three Hundred Ninety-One Thousand, Three Hundred Thirty-Eight Dollars and	

86/100 Dollars (\$391,338.86) is hereby appropriated from the proceeds of the 3/8-Cent Capital Sales and

1	Compensating Use Tax to reimburse the Arkansas Livestock Show Association for capital improvements on the		
2	main gate, perimeter fencing, and south parking lot.		
3	Section 2. Funds for this appropriation are available in Account No. 326459, Activity TS45A09.		
4	Section 3. Severability. In the event any section, paragraph, item, sentence, clause, phrase or word of this		
5	resolution is declared or adjudged to be invalid or unconstitutional, such declaration or adjudication shall not		
6	affect the remaining portions of the resolution which shall remain in full force and effect as if the portion so		
7	declared or adjudged invalid or unconstitutional were not originally part of this resolution.		
8	Section 4. Repealer. All laws, ordinances, resolutions, or parts of the same that are inconsistent with the		
9	provisions of this resolution are hereby repealed to the extent of such inconsistency.
