NARRATIVE

GONZALZE SAID AT ABOUT 2138 HOURS ON 03/24/2022 ONE OF THE EMPLOYEES WENT OUT THE BACK DOOR OF THE BUSINESS TO TAKE OUT THE TRASH. GONZALEZ SAID THE EMPLOYEE WAS FOLLOWED BACK INTO THE KITCHEN BY A HEAVY SET BLACK MALE WEARING ALL BLACK WITH A WHITE SKI MASK AND BLACK GLOVES. THE SUSPECT WAS WAIVING A BLACK HANDGUN AND DEMANDING MONEY. GONZALEZ SAID THEY GAVE THE SUSPECT ONE (1) DOLLAR AND TOLD HIM THAT WAS ALL THEY HAD ACCESS TO.
