## **NARRATIVE**

ON MONDAY, AUGUST 1, 2022, AT APPROXIMATELY 0831 HOURS, OFFICERS WERE DISPATCHED TO 10124 WHISPERING PINE DRIVE IN REFERENCE TO AN ASSIST MEDICAL CALL FOR SERVICE. THE CALLER STATED THAT SHE CAME HOME AND FOUND HER HUSBAND UNRESPONSIVE IN THE DRIVEWAY BLEEDING FROM THE MOUTH. OFFICERS ARRIVED ON SCENE AND FOUND MR. FELTON SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS ARRIVED AND PRONOUNCED MR. FELTON DECEASED. HOMICIDE AND CSSU WERE NOTIFIED AND RESPONDED.

HOMICIDE DETECTIVES CANVASSED THE NEIGHBORHOOD AND INTERVIEWED WITNESSES. CSSU PROCESSED THE SCENE. THE CORONER RESPONDED AND TOOK CUSTODY OF MR. FELTON AND TRANSPORTED HIM TO THE MEDICAL EXAMINERS OFFICE FOR AND AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THIS INVESTIGATION IS ONGOING.
