UPON ARRIVAL, OFFICERS LOCATED TREMONIE BRUAL (B/M; 05/13/2003) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS RESPONDED AND TRANSPORTED MR. BRUAL TO A LOCAL HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES AND WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE. THE PULASKI COUNTY CORONER RESPONDED TO THE HOSPITAL AND TOOK POSSESSION OF MR. BRUAL FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ONGOING.
