## **NARRATIVE**

ON TUESDAY, OCTOBER 18, 2022, AT APPROXIMATELY 2340 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED A SUBJECT SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED AND TRANSPORTED THE VICTIM TO A LOCAL HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES AND WAS PRONOUNCED DECEASED. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE FOOTAGE. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF THE DECEASED SUBJECT FOR AN AUTOPSY AND POSITIVE IDENTIFICATION. THE NEXT OF KIN IS PENDING. THE INVESTIGATION IS ON-GOING.
