NARRATIVE

ON SUNDAY, DECEMBER 18, 2022 AT APPROXIMATELY 2103 HOURS, OFFICERS RESPONDED TO A SHOTS FIRED CALL FOR SERVICE AT THE LOCATION OF #4 TOREY PINES DRIVE. COMMUNICATIONS THEN RECEIVED A CALL FROM A FEMALE SUBJECT WHO ADVISED SHE WAS JUST SHOT AT. UPON OFFICERS ARRIVAL CONTACT WAS MADE WITH A MALE SUBJECT LATER IDENTIFIED AS KENNETH PERKINS WHO WAS SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS WAS NOTIFIED TO RESPOND. MEMS ARRIVED ON SCENE AND TRANSPORTED MR. PERKINS TO CHILDREN??'S HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES. OFFICERS MADE CONTACT WITH MIRACLE BROWN ON SCENE WHO TOLD OFFICERS SHE FIRED SHOTS, DUE TO SOME SUBJECTS ATTEMPTING TO ROB HER WITH A GUN. MS. BROWN WAS TRANSPORTED TO THE MAJOR CRIMES DIVISION. OFFICERS ALSO MADE CONTACT WITH TWO OTHER SUBJECTS WHO WERE SAID TO BE WITH MR. PERKINS AND TRANSPORTED THEM TO THE MAJOR CRIMES DIVISION. HOMICIDE DETECTIVES AND CRIME SCENE PERSONNEL WERE NOTIFIED TO RESPOND.

HOMICIDE DETECTIVES ARRIVED ON SCENE AND BEGAN TO PRELIMINARY INVESTIGATION. DETECTIVES CANVASSED THE SCENE FOR WITNESSES AND SURVEILLANCE.
