7	WHEREAS, the City of Little Rock's Historic District Commission ("Historic District Commission")		
8	was established pursuant to Little Rock, Arkansas, Rev. Code § 23-96; and		
9	WHEREAS, the Historic District Commission has various duties regarding all local ordinance districts		
10	including, but not limited to, the creation and review of historic district guidelines, ensuring that periodic		
11	architectural surveys of all local ordinance districts are conducted, and determining the appropriateness o		
12	proposed changes to buildings and structures in the local ordinance districts; and		
13	WHEREAS, Little Rock, Arkansas, Rev. Code § 23-97(a) provides that the Historic District		
14	Commission consist of seven (7) members; and		
15	WHEREAS, the City's Board of Directors recently created the Central High School Historic District		
16	local ordinance district, Ordinance No (month, day, 2023); and		
17	WHEREAS, due to the creation of the new local ordinance district the duties of the Historic District		
18	Commission have been significantly increased; and		
19	WHEREAS, the Historic District Commission has reviewed the proposed changes to the ordinance in		
20	its regularly scheduled meeting and has approved of the proposed changes; and		
21	WHEREAS, Ark. Code Ann. § 14-172-206(a)(1) provides that a historic district commission shall		
22	consist of no less than five (5) members nor more than nine (9) members; and		
23	WHEREAS, there is a need to increase the membership of the Historic District Commission to address		
24	the additional needs of the Central High School Neighborhood Historic District local ordinance district and		
25	the residents and property owners therein.		
26	NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY		
27	OF LITTLE ROCK, ARKANSAS.		
28	Section 1. That Little Rock, Arkansas Rev. Code Chapter 23, Article IV, § 23-97(a) is amended a
