ON WEDNESDAY, JANUARY 11TH, 2023 AT APPROXIMATELY 2114 HOURS, OFFICERS RESPONDED TO 1001 BRECKENRIDGE DRIVE IN REFERENCE TO A BURGLARY IN PROGRESS CALL FOR SERVICE. THE CALLER, MS. MCKENZLY, ADVISED SHE CAME HOME AND FOUND VICTIM 1 WRAPPED IN A BLANKET AND DECEASED. OFFICERS ARRIVED AND LOCATED A DECEASED FEMALE WRAPPED IN A BLANKET IN THE PARKING LOT. OFFICERS DETAINED MS. MCKENZLY PENDING FURTHER INVESTIGATION. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE CONTACTED AND RESPONDED TO BEGIN A PRELIMINARY INVESTIGATION.

MS. MCKENZLY WAS READ HER MIRANDA RIGHTS AND AGREED TO PROVIDE A RECORDED STATEMENT. MS. MCKENZLY ULTIMATELY STATED SHE STABBED THE VICTIM NUMEROUS TIMES AND MOVED THE BODY FROM THE APARTMENT TO THE PARKING LOT TO ATTEMPT TO PUT HER IN HER VEHICLE. PULASKI COUNTY CORONERS OFFICE RESPONDED AND TRANSPORTED THE FEMALE TO THE ARKANSAS STATE CRIME LAB FOR AN AUTOPSY AND POSITIVE IDENTIFICATION. A SEARCH AND SEIZURE WARRANT WAS OBTAINED FOR THE APARTMENT AND IS PENDING BEING SERVED DURING THE ALLOTTED TIME OF 0600.

MS. MCKENZLY WAS CHARGED WITH MURDER IN THE FIRST DEGREE, TAMPERING WITH PHYSICAL EVIDENCE, AND ABUSE OF A CORPSE AND WAS TRANSPORTED TO PCRJ WITHOUT INCIDENT.
