Welcome and Introductions: Chairman Buie called the meeting to order and welcomed everyone present. Chairman Buie proceeded with the agenda to the roll call and approval of December' minutes.

# **Recreation**

Deputy Director Shawanda Robinson started reports by mentioning that the Recreation division has hired for the Golf Asst. Facility Supervisor position at Rebsamen Golf Course. We are currently interviewing for Assistant Facility Supervisor position at the Tennis Facility.

Community Centers: Youth Basketball program is going on with the games being Monday thru Thursday with some on Saturday.

Senior Program Group are back on regular schedule with the regular program and activities.

Therapeutic Recreation Group is back from Christmas Break and getting back acclimated to their social skills by volunteering at the zoo and other places.

MacArthur Museum has started back with their schedule field trip group within the area. They have field trips booked for about fifty-four (54) fifth (5<sup>th</sup>) graders from Carver Elementary in February. Three Hundred seventh (7<sup>th</sup>) graders from Greenbrier Middle School will be visiting the museum in March.

Athletic Division is preparing for summer playground program. We are in the process of getting Jobs advertise for the summer. Registration for the summer program begins on March 1, 2023 with the program starting on March  $12^{th}$  – July 20, 2023. The site has not been named, however, we are currently working to finalize all location for the summer playground program.

Exciting NEWS, Rebsamen Golf and First Tee have new POS system and went live on January 1<sup>st</sup>. This system will cut down on how we check someone in and out.

# **Operations**

The Western Hill playground work is coming along well. The pavilion is up and looking good. The staff was on site to finish up some work.

The Dunbar Gardner entrance sign, staff will start the end of the week to pour concrete and place the sign the next week after the concrete.

Upcoming project focus: The month of February will be MacArthur Park around the pond area and other things within the park before the opening.

# Parks Maintenance

Parks Maintenance Manager, J.P. Rogers opened parks maintenance reports by stating they are in the process of hiring three more position in maintenance. Trying to develop a trail crew to get the Trail Coordinator some help. Also advertising for CDL driver for anyone who wants to apply.

Chairman Buie asked the commissioner if they had any questions about any of the staff reports. There were no questions asked.

Commissioner Cannon Fletcher asked a questions "What is the estimated timeline for the Kanis Bridge part of it."

Director Couch answered by saying they are thankful for the federal programming grant for providing funding for it. It is part of our Kanis Basketball construction. The contractor is planning on installing the concrete as soon as possible. However, the contractors does not have a date when they will start the project. They will construct a temporary parking lot because the park will have limited access when they start the construction.

Chairman Buie thanked the staff for putting together the report and thank the commissioners for their questions.

# Old Business

Chairman Buie opened up old business by stating the commission do not have anyone currently leading the charge of social media & outreach sub-committee. He asked if anyone was interested on leading the charge.

# Sub-Committee Report

• <u>Master Plan</u>

Chairman Buie reported that Commissioner Linda Smith submitted a report of the Master Plan subcommittee via email.

Director Couch nominated either Commissioner France or Fletcher to discuss with the commission what they discussed from the Master Plan meeting last week.

Commissioner Fletcher stated that Commissioner Linda Smith had been to prior meeting with the subcommittee but the other commissioner had not. It was nice to meet with Leland and his staff to go through the Master Plan that was adopted in 2020 by the city board. One of the things we all shared is that it's more like a checklist instead of a visionary plan. The third point we talked about connectivity and thank the LRPR team for the summary they are providing. The committee will like to propose a park or two a month to discuss at each commission meeting only to support the LRPR in their park updates.

Chairman Buie thank Commissioner Fletcher for his report from the Master Plan meeting

• Parks Conservancy

Chairman Buie gave update on Park Conservancy, the supportive member friends program is being constructed and I anticipate the Park Conservancy Board will at the next meeting Wednesday, February 1<sup>st</sup> will approve the Friends program and it can go live at that point.

Additional communication will be sent out later. Either I or the park conservancy liaison who will be appointed in a second will be able to report at the next meeting.

Chairman Buie asked Commissioner Eldridge if she would consider being the Parks Conservancy Liaison.

Commissioner Eldridge agreed to Liaison position

Attorney Beth Carpenter interjected and asked Chairman Buie to call for a motion and vote to make it official.

Commissioner France made the motion to allow Commissioner Eldridge to be the Parks Conservancy Liaison for this coming year.

Commissioner Fletcher second the motion

# Golf Tournament

Commissioner Eldridge informed the commission the Golf Tournament will be May 19, 2023. The most important thing is the beverage and some of the food and snacks has already been arrange. The biggest lift from Eldridge and other commissioner is sponsorships. She is trying to edit the marketing sign that was used in the past for the Golf tournament. Commissioner Eldridge will take any input from anyone regarding levels of sponsorship. In years past there have been two different levels of sponsorship with one being \$250 and the other \$500. Commissioner Eldridge think those levels should be raised a little because of corresponding benefits that deals with advertising itself and in the golf cart. Commissioner Eldridge open the floor for any questions or idea related to sponsorship. It is the commissioner Eldridge think this will be a great moment to highlight other events that is going on around Parks & Recreation. Within a month all documents will be finalize.

Commissioner Ben France asked if Commissioner Eldridge can send out a list of sponsors from last year as well as last year flyer

Deputy Director Shawanda Robinson asked if she and another LRPR employee can meet with Commissioner Eldridge to see her needs so the department can assist with as much as possible.

Commissioner Eldridge stated she thinks that would be great, because one of her needs is getting an option for online payment for sponsorship. She would like to see something set up for potential sponsors to pay online before the tournament.

DD Robinson thinks the new system may have some amenities inside to help us with that online payment prior to the tournament.

Director Couch asked a question, have there ever been a discount for early registration in the past, now since there is a date can there be some type of advertising for anyone sign up before March will receive a certain amount of discount for registering. Maybe with that incentive there will be more teams to sign up sooner.

Chairman Buie thanked everyone for their ideas

Commissioner Fletcher asked where there a cost outside the food to operate or are there a fee for the rounds

Commissioner Eldridge replied that Rebsamen has been very generous in allowing us to make use of their facility without payment. I think we can talk about the cost in future meetings that if we meet a certain goal or exceed that goal then we can make any exchange.

Chairman Buie asked where there any other questions for the tournament discussion. No other questions was asked, therefore he thanked everyone for their responses.

Chairman Buie then proceeds to New Business.

Chairman Buie open discussing with referring back to Commissioner Fletcher statement on highlighting a park each month for discussion. The park for the month of February was Boyle Park.

Chairman Buie asked Director Couch if he wanted to speak on the request

#### <u>Marathon</u>

Marathon is back on normal schedule, since the last twelve (12) months there have been two marathon events to catch up from COVID. This year will be the 21<sup>st</sup> annual marathon which will take place on March 3-5, 2023 with a Health and Fitness Expo on Friday and Saturday from 10-8PM on Friday and 10-6PM on Saturday at the State House Convention Center. Saturday morning at 7:30am there will be a 5K and 10K and at 11am there will be a Little Rocker mile

race. The Little Rockers program run their first 25.2 miles since the start of school and on Marathon weekend they run their final mile for their medal. On Sunday is our marathon and our half marathon. We start at 6AM with an early start for marathon and at 8AM we have a general start for the half marathon and the other participants. Health & Fitness Expo, we want to make it more experience and more things to do and attract local community as well. We want to highlight Parks Department throughout the Expo. There will be a DJ onsite as well as basketball set up for fun. We will use this to promote things throughout the Parks Department and we would love for the commission to be present as well. We want to promote Parks and the Commission at this event. This is a free event.

Michael Garrity encourage the commissioner to come and see behind the scenes prior to setup.

Director Couch also informed the commissioner of the new medical clinic that is operating at West Central Community Center. It is a separate center but it's open to the public. We also have a radio station at West Central who gets great numbers from people who listen. We can put flyers and any other announcements on for airing.

DD Robinson informed everyone the name of the radio station was KWCP 98.9

Director Couch informed everyone the distance the radio station covers.
