The LRSC can participate in Dir. Phillip's new downtown density initiative, recommends direct touch and ask how LRSC can be helpful.

James Owen RFP is good to go except 1 piece of language about joint ventures. Sidewalk improvement fund (how to dedicate funding), James needs help to review scholarly research about a similar project that happened in Austin, TX. Boards and Commissions Clinton School Project, will definitely share this meeting recording with her, as it's a perfect highlight to the issues of structure, consistency, and orientation.
