CRAYTON EXITED THE VEHICLE AND THE SUSPECT FLED. UPON FURTHER INQUIRY ON WHAT HAPPENED, MS. DILLARD STATED THE SUSPECT WAS ACTUALLY HER FRIEND, MR. ALEXANDER, WHOM HAD BEEN DRIVING HER VEHICLE FOR A FEW DAYS. MS. DILLARD WENT ON TO EXPLAIN SHE HAD BEEN SEARCHING FOR THE VEHICLE AND WAS ABLE TO FIND IT, ONLY AFTER MR. ALEXANDER PICKED HER AND HER DAUGHTER UP IN IT. MS. DILLARD WENT ON AND STATED SHE ASKED FOR HER VEHICLE WHILE THEY WERE STOPPED AT THE LISTED LOCATION. MR. ALEXANDER, WHO WAS DRIVING AT THE TIME, REFUSED TO GIVE MS. DILLARD HER VEHICLE. MS. DILLARD ADVISED SHE THEN EXITED THE VEHICLE AND WENT TO THE DRIVER SIDE DOOR AND DEMANDED HER VEHICLE, SHE ADVISED THAT WAS WHEN MR. ALEXANDER BRANDISHED THE KNIFE AND STATED HE WOULD CUT HER IF SHE DID NOT GIVE HIM THE VEHICLE. WHILE THE RESPONDING OFFICER WAS MAKING CONTACT WITH MS. DILLARD, DOWNTOWN UNITS LOCATED THE VEHICLE TRAVELING ON ASHER AND CONDUCTED A TRAFFIC STOP AT 2318 BROWN ST. MR. ALEXANDER WAS FOUND TO BE DRIVING THE VEHICLE WITH MS. BENNETT AS A PASSENGER. SERGEANT HUTCHINSON RESPONDED TO THE SCENE. BOTH MR. ALEXANDER AND MS. BENNETT WERE DETAINED AND TRANSPORTED TO THE 12TH STREET DO. MS. BENNETT WAS FOUND TO NOT BE INVOLVED WITH THE CRIME AND RELEASED. DOWNTOWN UNITS WITH THE VEHICLE LOCATED A LARGE KNIFE ON THE DRIVER SIDE FLOORBOARD. OFFICERS WITH MS. DILLARD TRANSPORTED HER AND MS. CRAYTON TO THE LOCATION OF HER VEHICLE WHERE SHE TOOK POSSESSION OF IT. MS. DILLARD AND MS. CRAYTON WENT TO THE 12TH STREET DO TO MAKE A STATEMENT WITH DETECTIVES. DETECTIVES AT 12TH STREET ADVISED DURING AN INTERVIEW WITH MS. DILLARD, SHE STATED MR. ALEXANDER NEVER PULLED A KNIFE ON HER AND HE JUST TOOK HER VEHICLE. SHE WENT ON TO STATE THAT SHE DID NOT WANT TO PRESS CHARGES ON MR. ALEXANDER. MR. ALEXANDER WAS RELEASED FROM CUSTODY. NO FURTHER ACTION WAS TAKEN. MVR/BWC IN USE.
