ON TODAYS DATE, I WAS INFORMED BY A SUPERVISOR TO CREATE A REPORT FOR A BATTERY 1ST DEGREE. ON 05/29/2023 A HOMICIDE OCCURRED AT THE SAME TIME AS THIS INCIDENT.
