NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A DISTURBANCE WITH A WEAPON. COMMUNICATIONS ADVISED THREE SUBJECTS ARE INSIDE ARGUING WITH SECURITY AND THEY BELIEVE ONE OF THEM HAS A GUN. WHEN OFFICERS ARRIVED ALL THE SUSPECTS ALREADY LEFT THE AREA. OFFICERS ARRIVED AND MADE CONTACT WITH VICTIM#2 (SECURITY) AND OWNER#1 (MANAGER). VICTIM#2, KENNETH BROWN (B/M 09/25/1983) STATED THAT THE THREE SUSPECTS WERE STEALING ITEMS FROM THE STORE AND WHEN HE APPROACHED THEM, SUSPECT#1 INDICATED TO HIM THAT HE HAD A WEAPON. MR. BROWN STATED THAT SUSPECT#1 STATED "DON'T PUSH UP ON ME." MR. BROWN STATED THAT THE SUSPECT THEN REACHED FOR A FIREARM INSIDE A SMALL YELLOW HANDBAG, AND MR. BROWN STATED THAT HE THEN POINTED THE FIREARM AT HIM (BLACK PISTOL). MR. BROWN STATED THAT HE THEN BACKED OFF THE SUSPECTS AND THEY WERE LAST SEEN RUNNING TOWARD 13600 OTTER CREEK PARKWAY. OFFICERS MADE CONTACT WITH ANOTHER WITNESS (WITNESS#1 RILEY NOEL B/M) AND HE STATED THAT HE ALSO WITNESSED SUSPECT#1 PULL A FIREARM OUT OF HIS SMALL HANDBAG, WHILE ARGUING WITH THE SECURITY GUARD. OWNER#1, TRAVIS EVANS (W/M MANAGER) SHOWED OFFICERS THE VIDEO FOOTAGE FROM THE INCIDENT, HOWEVER OFFICERS WERE UNABLE TO SEE THE TIME FRAME WHEN THE SUSPECT PULLED OUT THE FIREARM.
