## **NARRATIVE**

ON WEDNESDAY, JUNE 21, 2023, AT APPROXIMATELY 0253 HOURS, OFFICERS RESPONDED TO 11701 MARA LYNN (NORTHWEST APARTMENTS) ON A SHOOTING JUST OCCURRED CALL FOR SERVICE. OFFICERS ARRIVED ON SCENE AND LOCATED A B/M, LATER IDENTIFIED AS IMMANUEL TURNER SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS WAS NOTIFIED TO RESPOND. MEMS ARRIVED AND BEGAN TREATING MR. TURNER. MEMS TRANSPORTED TO MR. TURNER TO BAPTIST HOSPITAL WHERE MR. TURNER SUCCUMBED TO HIS INJURIES. MR. TURNER WAS PRONOUNCED DECEASED. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK CUSTODY OF MR. TURNER'S BODY. THE CORONER WILL SUBMIT THE BODY TO THE ARKANSAS CRIME LAB FOR AN AUTOPSY.

DURING THE INVESTIGATION OFFICERS MADE CONTACT WITH HALIA HOUSTON WHO WAS TAKEN IN CUSTODY AND TRANSPORTED TO THE MAJOR CRIMES DIVISION.

HOMICIDE DETECTIVES WERE NOTIFIED AND RESPONDED TO THE SCENE, BAPTIST HOSPITAL AND THEN TO THE MAJOR CRIMES DIVISION. DETECTIVES MADE CONTACT WITH MS. HOUSTON AT THE MAJOR CRIMES DIVISION WHO WAS READ HER MIRANDA RIGHTS. MS. HOUSTON ADVISED SHE UNDERSTOOD HER RIGHTS AND PROVIDED A STATEMENT. MS. HOUSTON WAS CHARGED WITH MURDER 1ST DEGREE AND TRANSPORTED TO PCRJ.
