NARRATIVE

ON TUESDAY JULY 11, 2023, AT APPROXIMATELY 1534 HOURS, OFFICERS WERE DISPATCHED TO A ???????SHOT SPOTTER ACTIVATION?????? NEAR THE LOCATION OF 2110 S. PINE STREET. COMMUNICATIONS ADVISED OF SEVERAL CALLS FOR SHOTS FIRED IN THE AREA AS WELL AS A CALLER THAT STATED A SUBJECT WAS ON THE GROUND. OFFICERS ARRIVED AND LOCATED BRANDAN RAY AND BRODERICK RAY SUFFERING FROM APPARENT GUNSHOT WOUNDS NEAR 2113 AND 2115 S. PINE STREET. MEMS ARRIVED TO PROVIDE LIFESAVING MEDICAL AID BUT BOTH SUBJECTS WERE PRONOUNCED DECEASED ON SCENE. A THIRD SHOOTING VICTIM, TYRONE NUTT WAS LOCATED AT 2113 S. PINE SUFFERING FROM AN APPARENT GUNSHOT WOUND. HE WAS TRANSPORTED TO UAMS FOR FURTHER TREATMENT. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE CONTACTED AND RESPONDED.

HOMICIDE DETECTIVES ARRIVED AND BEGAN A PRELIMINARY INVESTIGATION, SPEAKING WITH WITNESSES AND SEARCHING FOR POSSIBLE SURVEILLANCE CAMERAS. DURING THE COURSE OF THE INVESTIGATION, INFORMATION WAS OBTAINED TO IDENTIFY MR. NUTT AS A SUSPECT IN THE INCIDENT AS WELL AS IDENTIFIED TYREE WATERS AS THE SECOND SUSPECT. MR. NUTT WAS TRANSPORTED TO THE MAJOR CRIMES DIVISION ONCE HE WAS RELEASED FROM THE HOSPITAL. HE WAS READ HIS MIRANDA RIGHTS AND WAIVED THOSE RIGHTS TO PROVIDE A STATEMENT. HE WAS CHARGED WITH CAPITAL MURDER AND TRANSPORTED TO THE PULASKI COUNTY REGIONAL DETENTION FACILITY. THE PULASKI COUNTY CORONER'S OFFICE WAS CONTACTED AND RESPONDED. THE BODY OF BOTH SUBJECTS WERE TRANSPORTED TO THE ARKANSAS STATE CRIME LAB PENDING AUTOPSY. THE NEXT OF KIN WAS NOTIFIED.
