NARRATIVE

ON SATURDAY, JULY 15, 2023 AT APPROXIMATELY 0543 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH MALE VICTIM, LATER IDENTIFIED AS WALTER HAIR JR. WHO WAS SUFFERING FROM MULTIPLE APPARENT GUNSHOT WOUNDS. MEMS WAS NOTIFIED AND RESPONDED. MEMS TRANSPORTED MR. HAIR JR. TO UAMS ER WHERE HE SUCCUMBED TO HIS INJURIES. OFFICERS WERE LATER NOTIFIED THAT ANOTHER VICTIM, LATER IDENTIFIED AS DERRICK WEAVER HAD ARRIVED AT ST. VINCENT ER AND WAS SUFFERING FROM AN APPARENT GUNSHOT WOUND TO HIS NECK. IT WAS LATER DETERMINED THAT DERRICK WEAVER AND WALTER HAIR JR. WERE BOTH INVOLVED IN THE SAME INCIDENT AT THE SAME LOCATION. HOMICIDE DETECTIVES WERE NOTIFIED AS WELL AS CRIME SCENE PERSONNEL. DETECTIVES ARRIVED ON SCENE AND BEGAN TO PRELIMINARY INVESTIGATION. DETECTIVES MADE CONTACT WITH WITNESS AND CANVASSED FOR ANY VIDEO EVIDENCE. DETECTIVES MADE CONTACT WITH MR. WEAVER AT ST. VINCENT ER. MR. WEAVER ADVISED THAT HE RATHER HAVE HIS ATTORNEY PRESENT BEFORE PROVIDING A STATEMENT. PULASKI COUNTY CORONER OFFICE RESPONDED TO UAMS HOSPITAL AND TOOK CUSTODY OF MR. HAIR JR'S BODY. MR. HAIR JR'S BODY WILL BE SUBMITTED TO THE CRIME LAB FOR AUTOPSY. NEXT OF KIN WAS NOTIFIED. INVESTIGATION IS ONGOING.
