NARRATIVE

ON TUESDAY, AUGUST 1ST, 2023 AT APPROXIMATELY 2122 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED KHALILA MARTINDALE JR (B/M; 11/10/1997) SUFFERING FROM AN APPARENT GUNSHOT WOUND. RESCUE RESPONDED TO THE SCENE, HOWEVER, MR. MARTINDALE WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE. DURING THE COURSE OF THE INVESTIGATION, ERIC DAVIS (B/M; 03/15/1999), EVELYN ALEXANDER (B/F; 01/02/2002) AND MARQUIS SMITH (B/M; 05/14/2000) WERE DEVELOPED AS SUSPECTS IN THIS INCIDENT. DETECTIVES LOCATED ALL SUBJECTS AND THEY WERE TRANSPORTED TO MAJOR CRIMES. AFTER FURTHER INVESTIGATION, MR. DAVIS AND MS. ALEXANDER WERE CHARGED WITH CAPITAL MURDER. MR. SMITH WAS CHARGED WITH CAPITAL MURDER AND UNRELATED NARCOTICS CHARGES. ALL THREE SUBJECTS WERE TRANSPORTED TO PCRJ WITHOUT INCIDENT. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. MARTINDALE FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
