NARRATIVE

ON AUGUST 4, 2023 AT APPROXIMATELY 0240 HOURS, OFFICERS RESPONDED TO THE AMERICA'S VALUE INN IN REFERENCE TO A CUTTING. COMMUNICATIONS ADVISED THE CALLERS STATED HIS WIFE FELL ON A KNIFE. OFFICERS ARRIVED AND LOCATED ROMESHA SIMMONS ON THE FLOOR OF ROOM 133 WITH INJURIES CONSISTANT WITH A STABBING. MEMS PERSONNEL ARRIVED AND TRANSPORTED HER TO UAMS FOR FURTHER TREATMENT. THE CALLER, TADESE PATRICK WAS SECURED AND TRANSPORTED TO THE MAJOR CRIMES DIVISION. MS. SIMMONS WAS LATER PRONOUNCED DECEASED AT UAMS. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE CONTACTED AND RESPONDED. HOMICIDE DETECTIVES ARRIVED AND BEGAN A PRELIMINARY INVESTIGATION, SPEAKING WITH WITNESSES AND SEARCHING FOR POSSIBLE SURVIELLANCE CAMERAS. THE PULASKI COUNTY CORONER'S OFFICE WAS CONTACTED AND RESPONDED. THE BODY OF MS. SIMMONS WAS TRANSPORTED TO THE ARKANSAS STATE CRIME LAB PENDING AN AUTOPSY. DETECTIVES LATER CHARGED MR. PATRICK WITH MURDER IN THE FIRST DEGREE AND HE WAS TRANSPORTED TO PCRJ WITHOUT INCIDENT. NEXT OF KIN WAS NOTIFIED.
