UPON ARRIVAL, OFFICERS LOCATED DARRIN SUFFERING FROM APPARENT GUNSHOT WILLIAMS (B/M; 01/04/2007) TO A LOCAL HOSPITAL FOR WOUNDS. MEMS AND RESCUE RESPONDED AND TRANSPORTED MEDICAL ATTENTION. MR. WILLIAMS WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE FOOTAGE AND WITNESSES. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. WILLIAMS FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
