NARRATIVE

LAFAVORS SUFFERING FROM APPARENT GUNSHOT WOUNDS AND APPARENTLY DECEASED. OFFICERS SECURED A CRIME SCENE AND NOTIFIED HOMICIDE DETECTIVES AND CSSU PERSONNEL. DETECTIVES BEGAN A PRELIMINARY INVESTIGATION CANVASSING THE AREA FOR WITNESSES AND VIDEO SURVEILLANCE. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. LAFAVORS BODY AND TRANSPORTED HIM TO THE ARKANSAS STATE CRIME LAB FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON GOING.
