## **NARRATIVE**

ON WEDNESDAY, SEPTEMBER 13, 2023 AT APPROXIMATELY 1811 HOURS, OFFICERS RESPONDED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE MAIN STAY HOTEL, LOCATED AT 10800 KANIS ROAD APT 117. UPON OFFICERS ARRIVAL CONTACT WAS MADE WITH A B/M VICTIM LATER IDENTIFIED AS JONATHAN FOSTER (05/03/1993) WHO WAS SUFFERING FROM APPARENT GUNSHOT WOUNDS. OFFICERS NOTIFIED MEMS TO RESPOND. MEMS ARRIVED ON SCENE AND BEGAN LIFE SAVING MEASURES. MEMS TRANSPORTED MR. FOSTER TO BAPTIST HOSPITAL WHERE HE SUCCUMBED TO HIS INJURIES. OFFICERS MADE CONTACT WITH WITNESSES AND TRANSPORTED THEM TO THE MAJOR CRIMES DIVISION. HOMICIDE DETECTIVES ALONG WITH CSSU RESPONDED TO THE SCENE. HOMICIDE DETECTIVES BEGAN THE PRELIMINARY INVESTIGATION. DETECTIVES MADE CONTACT WITH WITNESSES, VIEWED AND RETRIEVED VIDEO SURVEILLANCE. THE PULASKI COUNTY CORONER'S RESPONDED TO BAPTIST HOSPITAL AND TOOK CUSTODY OF MR. FOSTER'S BODY. MR. FOSTER BODY WILL BE SUBMITTED TO THE CRIME LAB FOR AN AUTOPSY.

AFTER FURTHER INVESTIGATION A CAPITAL MURDER WARRANT WAS ISSUED FOR A B/M IDENTIFIED AS BRANDON JONES (12/16/1990).
