NARRATIVE

ON FRIDAY, OCTOBER 13, 2023, AT APPROXIMATELY 1651 HOURS, OFFICERS RESPONDED TO THE LOCATION OF MABELVALE DRIVE AND MABELVALE CIRCLE ON SUBJECT DOWN CALL FOR SERVICE. UPON OFFICERS ARRIVAL, CONTACT WAS MADE WITH TWO B/M'S LATER IDENTIFIED AS MARVIN JENKINS (08/28/1976) AND MARVIN JENKINS (01/16/2002) WHO WERE BOTH SITTING IN A VEHICLE, SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS RESPONDED TO THE LOCATION AND ATTEMPTED LIFE SAVING MEASURES, BUT BOTH VICTIMS SUCCUMBED TO THEIR INJURIES ON SCENE. OFFICERS SECURED THE SCENE, NOTIFIED HOMICIDE AND CSSU.

HOMICIDE DETECTIVES ARRIVED ON SCENE AND BEGAN THE PRELIMINARY INVESTIGATION. DETECTIVES CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE VIDEO.

THE PULASKI COUNTY CORONER OFFICE WAS NOTIFIED AND RESPONDED. THE CORONER TOOK POSSESSION OF BOTH VICTIMS. THEY WILL BOTH BE SUBMITTED TO THE CRIME LAB FOR AUTOPSY.
