OFFICERS RESPONDED TO THIS LOCATION ON A REPORT OF SHOTS FIRED. OFFICERS MET WITH JALYN WATKINS WHO ADVISED HE HAD BEEN ROBBED OF \$221 IN CASH THAT WAS IN THE CAB OF HIS WORK TRUCK. WATKINS HAD BEEN WORKING AND NOTICED THE MONEY MISSING. WATKINS SPOKE TO AN ONSITE CONTRACTOR, CHARLES JOHNSON, WHO ADVISED A WHITE FEMALE (LATER IDENTIFIED AS APRIL LONGSTIN) WHO WAS ON THE SCENE HAD BEEN RUMMAGING INSIDE THE TRUCK. WATKINS CONFRONTED LONGSTIN AND SHE FIRED ONE SHOT BEFORE WALKING OFF HEADING SOUTHBOUND ON LONGCOY STREET HEADING TOWARD 34TH STREET. A VEHICLE OCCUPIED BY THE SITE MANAGER, STANLEY PHILLIPS, WAS STRUCK BY THE PROJECTILE. LONGSTIN WAS OBSERVED ENTERING A GRAY TOYOTA. SUPERVISOR, MAJOR CRIMES DETECTIVES AND CSSU RESPONDED TO THE SCENE. CHARLES JOHNSON FOLLOWED THE VEHICLE AND ADVISED 911. WILLIAMS THEN LAID ON THE GROUND AND ADVISED OFFICERS HE HAD BEEN SHOT IN HIS BUTTOCK AND THIGH. MR. WILLIAMS ALSO STATED HE WAS SITTING IN HIS VEHICLE, VEH1, WHEN HE WAS SHOT BY AN UNKNOWN MALE. MR. WILLIAMS ADDED NO DISTURBANCE HAD OCCURRED BETWEEN HE AND THE UNKNOWN MALE NOR HAD ANY WORDS BEEN EXCHANGED PRIOR TO THE UNKNOWN MALE FIRING ON HIM. MR.
