NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN RESPONSE TO A CRIMINAL MISCHIEF CALL. UPON ARRIVAL, OFFICERS OBSERVED A SHATTERED WINDOW IN THE FRONT OF THE BUSINESS. OFFICERS MADE CONTACT WITH THE SUPERVISOR (REDFORD) WHO ADVISED SHE DID NOT HEAR ANY GUNSHOTS BUT NOTICED THE WINDOW TO THE BUSINESS WAS SHATTERED. REDFORD STATED SHE AND HER EMPLOYEES DID NOT WITNESS THE INCIDENT OCCUR. REDFORD STATED A CUSTOMER (SUSPECT) GOT ANGRY WHEN THE EMPLOYEES WERE UNABLE TO TAKE HIS ORDER DUE TO THEIR SYSTEMS BEING DOWN. REDFORD STATED THE SUSPECT REFUSED TO LEAVE THE BUSINESS AND SHORTLY AFTER HE LEFT, SHE NOTICED THE WINDOW SHATTERED WITH A BULLET HOLE. REDFORD STATED THE SUSPECT WAS DRIVING A SILVER CHEVROLET IMPALA WITH TEMPORARY TAGS. REDFORD WAS UNABLE TO PROVIDE THE DIRECTION THE SUSPECTS LEFT IN.

LEA AND LANGHORE BOTH STATED THEY DID NOT WITNESS THE INCIDENT. BOTH EMPLOYEES REFUSED MEDICAL ATTENTION. OFFICERS DID NOT OBSERVE ANY DAMAGE INSIDE THE BUSINESS. OFFICERS CIRCULATED THE AREA FOR ANY SHELL CASINGS WITH NEGATIVE RESULTS. REDFORD STATED SHE WAS UNABLE TO ACCESS THE SECURITY FOOTAGE. THE GENERAL MANAGER STATED HE WOULD EMAIL THE FOOTAGE TO OFFICERS AFTER HE RETURNS TO THE STATE.

OFFICERS CONTACTED L35 WHO RESPONDED TO THE SCENE. DETECTIVES WERE NOTIFIED AND ADVISED OFFICERS TO PHOTOGRAPH THE DAMAGE. MVR AND BWC IN USE.

NARRATIVE

ON NOVEMBER 11, OFFICERS RESPONDED TO A REPORT OF A ROBBERY OF A BUSINESS.

UPON ARRIVAL OFFICERS MADE CONTACT WITH MR. MAYO WHO STATED, TWO MALE SUBJECTS ROBBED THE BUSINESS WHILE HOLDING HIM AT GUN POINT.

MR. MAYO STATED AT APPROXIMATELY 0145 TWO MALE SUBJECTS APPROACHED HIS VEHICLE AS HE WAS LEAVING THE RESTAURANT AND TAPPED ON THE WINDOW WITH WHAT HE THOUGHT WAS A FIREARM. MR. MAYO STATED HE STOPPED THE VEHICLE THINKING IT COULD HAVE BEEN AN UNKNOWN SUBJECT ASKING FOR FOOD, BUT STATED IT WAS TWO SUBJECTS WEARING MASKS ATTEMPTING TO ROB HIM.

MR. MAYO STATED AFTER STOPPING THE VEHICLE ONE OF THE MALES HELD A FIREARM TO HIS FACE DEMANDING HE RETURN TO THE STORE.

MR. MAYO STATED OUT OF FEAR OF BEING SHOT HE DID EXACTLY WHAT THEY ASKED HIM TO DO.

MR. MAYO STATED AS THEY ESCORTED HIM BACK INSIDE THE BUSINESS THEY HELD A FIREARM TO FACE. MAYO STATED BOTH MALE SUBJECTS ESCORTED HIM TO THE BACK WHERE THE SAFE COULD BE LOCATED AND DEMANDED HE FILL A TRASH BAG WITH THE CONTENTS OF THE SAFE.

MR. MAYO STATED BOTH SUBJECTS RAN IN AN UNKNOWN DIRECTION OF TRAVEL AFTER LEAVING.

OFFICERS THEN MADE CONTACT WITH MS. DUNN, WHO WAS NOT PRESENT AT THE TIME OF THE ROBBERY, WHO STATED THERE WAS APPROXIMATELY 1700.00 INSIDE THE SAFE PRIOR TO THE ROBBERY.

UPON FURTHER INVESTIGATION, OFFICERS OBSERVED AN OPEN SAFE AND SPARE CHANGE ON THE FLOOR OF THE OFFICE.

OFFICERS ALSO REVIEWED VIDEO RECORDING OF THE INCIDENT WHICH SHOWED TWO MALE SUBJECTS RUNNING FROM A DARK AREA BEFORE ENTERING THE BUSINESS WITH MR. MAYO.

VIDEO ALSO SHOWED MR. MAYO PUTTING WHAT APPEARED TO A LARGE SUM OF CASH INSIDE A WHITE TRASH BAG AND HANDING IT TO THE MALE SUBJECT.

MR. MAYO STATED SHORTLY AFTER THE INCIDENT HE NOTIFIED THE STORE MANAGER MS. DUNN WHO NOTIFIED THE POLICE OF THE INCIDENT AND INSTRUCTED MR. MAYO TO RETURN TO THE BUSINESS AFTER LEAVING.

OFFICERS THEN MADE CONTACT WITH MR. PHILLIPS WHO RECOGNIZED THE MALE SUBJECTS IN THE VIDEO AS TWO EMPLOYEES OF THE BUSINESS. THEY WERE IDENTIFIED AS JACQUEZ REYNOLDS AND MALCOLM CURRY.

A NORTHWEST SERGEANT AND THE ON-CALL DETECTIVE RESPONDED, MR. MAYO WAS TRANSPORTED TO 12TH STREET DO WHERE HE SPOKE TO DETECTIVES.

OFFICERS ISSUED A BROADCAST OF THE SUSPECTS LIKENESS. MVR WAS IN USE.
