OFFICERS MADE CONTACT WITH THE RESIDENTS OF THE DUPLEX AT 2115 SOUTH PINE STREET, VIC-1 (PETERS) IN APARTMENT B, AND VIC-2 (MORELAND) IN APARTMENT A. NARRATIVE

OFFICERS MADE CONTACT WITH JOE WESLEY. WESLEY INFORMED OFFICERS THAT MS. JOHNSON WAS AT HIS HOME VISITING. WESLEY STATED THAT HE TOLD JOHNSON THAT HE WAS GOING TO GIVE HER MONEY THE NEXT FOLLOWING DAY. WESLEY INFORMED OFFICERS THAT JOHNSON DEMANDED MONEY ON THIS DAY, WHICH HE DECLINED.

WESLEY THEN STATED THAT THE TWO GOT INTO AN ARGUMENT. HE EXPLAINED THAT HE WENT OUTSIDE AND ATTEMPTED TO WALK AWAY TO DIFFUSE THE SITUATION. WESLEY FURTHER EXPLAINED THAT JOHNSON RAN AFTER HIM AS HE ATTEMPTED TO WALK AWAY. ONCE CATCHING UP WITH HIM, WESLEY STATED THAT SHE WRESTLED HIM DOWN TO THE GROUND AND SNATCHED HIS PHONE, AND WALLET OUT OF HIS POCKET. HE STATED THAT HIS WALLET CONTAINED ABOUT \$600 CASH. JOHNSON WAS SAID TO HAVE FLED THE SCENE IN A MAROON SUV, THAT HE SAID BELONGS TO HER MOTHER. WESLEY REFUSED ANY MEDICAL TREATMENT AND OFFICERS OBSERVED NO VISIBLE SIGNS OF INJURY.

WESLEY WAS UNSURE OF AN APPROXIMATE ADDRESS FOR JOHNSON, BUT INFORMED OFFICERS THAT JOHNSON RESIDES IN SOME APARTMENTS NEAR A SKATING BUSINESS IN SOUTHWEST LITTLE ROCK.

WESLEY SHOWED OFFICERS THAT JOHNSON HAD BROKEN A WINDOW OUT ON THE EAST SIDE OF HIS HOUSE. HE WAS UNSURE WHAT SHE HIT HIS WINDOW WITH BUT CONFIRMED THAT JOHNSON WAS RESPONSIBLE. OFFICERS PUT OUT A BROADCAST AND CIRCULATED THE AREA FOR THE SUSPECT WITH NEGATIVE RESULTS.
