#### **NARRATIVE**

WHILE OFFICERS WERE ON ANOTHER CALL IN THE AREA, OFFICERS HEARD MULTIPLE SHOTS FIRED, INCLUDING AUTOMATIC GUNFIRE. DISPATCH ADVISED OF A SHOTSPOTTER ACTIVATION AT 2100 SOUTH PINE STREET INVOLVING APPROXIMATELY 63 SHOTS FIRED FROM MULTIPLE ACTIVATIONS. UPON ARRIVAL, OFFICERS LOCATED MULTIPLE SHELL CASINGS IN THE STREET NEAR THE INTERSECTION OF SOUTH PINE STREET AND WEST 21ST STREET AND IN THE YARD OF 2100 SOUTH PINE STREET.

OFFICERS MADE CONTACT WITH THE RESIDENTS OF THE DUPLEX AT 2115 SOUTH PINE STREET, VIC-1 (PETERS) IN APARTMENT B, AND VIC-2 (MORELAND) IN APARTMENT A. BOTH APARTMENTS OF 2115 SOUTH PINE STREET WERE STRUCK BY GUNFIRE MULTIPLE TIMES. BOTH VICTIMS ADVISED THEY WERE INSIDE THEIR APARTMENTS WHEN THE SHOTS FIRED OCCURRED. THEY DID NOT SEE ANYTHING, ONLY HEARING THE SHOTS FIRED, BUT PETERS DID SAY SHE HEARD A VEHICLE OUTSIDE WITH LOUD MUSIC BEFORE THE SHOTS.

OFFICERS ALSO MADE CONTACT WITH VIC-3 (WILLIFORD) AT 2118 SOUTH OAK STREET WHICH HAD BEEN STRUCK WITH GUNFIRE AS WELL. JUV-1 WAS ALSO INSIDE 2118 SOUTH OAK STREET WHEN IT WAS STRUCK BY GUNFIRE. WILLIFORD DID NOT SEE ANYTHING, ONLY HEARD THE SHOTS FIRED.

MAJOR CRIMES DETECTIVES AND CRIME SCENE RESPONDED AND PROCESSED THE SCENE. MVR AND BWC IN USE.

#### **NARRATIVE**

OFFICERS RESPONDED TO THE ABOVE LISTED LOCATION IN REFERENCE TO AN AGGRAVATED ROBBERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. GREG WILLIAMS WHO ADVISED HE WAS JUST ROBBED AT GUN POINT BY AN UNKNOWN SUSPECT. MR. WILLIAMS STATED THE UNKNOWN SUBJECT CAME INTO THE LOCATION, WALKED UP TO THE REGISTER AND ASKED HIM FOR CIGARETTES. MR. WILLIAMS STATED AFTER HE ASKED THE UNKNOWN SUSPECT FOR HIS I. D, THE UNKNOWN SUSPECT PULLED OUT A 9MM HANDGUN AND DEMANDED HIM TO OPEN THE REGISTER AND GIVE HIM ALL THE MONEY. MR. WILLIAMS HANDED HIM ALL OF THE MONEY FROM BOTH REGISTERS. THE SUSPECT THEN FLED ON FOOT, HEADED TOWARD RODNEY PARHAM. MR. WILLIAMS STATED HE DID NOT SEE A VEHICLE AT THIS TIME AND HE NOTIFIED HIS SUPERVISOR. OFFICERS MADE A BROADCAST AND NOTIFIED 3L34 OF THE INCIDENT AND HE NOTIFIED CRIME SCENE. MS. LESHUN REEVES ARRIVED ON SCENE AND OFFICERS WERE ABLE TO VIEW THE VIDEO FOOTAGE OF THE INCIDENT. #### **NARRATIVE**

OFFICERS MADE CONTACT WITH JOE WESLEY. WESLEY INFORMED OFFICERS THAT MS. JOHNSON WAS AT HIS HOME VISITING. WESLEY STATED THAT HE TOLD JOHNSON THAT HE WAS GOING TO GIVE HER MONEY THE NEXT FOLLOWING DAY. WESLEY INFORMED OFFICERS THAT JOHNSON DEMANDED MONEY ON THIS DAY, WHICH HE DECLINED.

WESLEY THEN STATED THAT THE TWO GOT INTO AN ARGUMENT. HE EXPLAINED THAT HE WENT OUTSIDE AND ATTEMPTED TO WALK AWAY TO DIFFUSE THE SITUATION. WESLEY FURTHER EXPLAINED THAT JOHNSON RAN AFTER HIM AS HE ATTEMPTED TO WALK AWAY. ONCE CATCHING UP WITH HIM, WESLEY STATED THAT SHE WRESTLED HIM DOWN TO THE GROUND AND SNATCHED HIS PHONE, AND WALLET OUT OF HIS POCKET. HE STATED THAT HIS WALLET CONTAINED ABOUT \$600 CASH. JOHNSON WAS SAID TO HAVE FLED THE SCENE IN A MAROON SUV, THAT HE SAID BELONGS TO HER MOTHER. WESLEY REFUSED ANY MEDICAL TREATMENT AND OFFICERS OBSERVED NO VISIBLE SIGNS OF INJURY.

WESLEY WAS UNSURE OF AN APPROXIMATE ADDRESS FOR JOHNSON, BUT INFORMED OFFICERS THAT JOHNSON RESIDES IN SOME APARTMENTS NEAR A SKATING BUSINESS IN SOUTHWEST LITTLE ROCK.

WESLEY SHOWED OFFICERS THAT JOHNSON HAD BROKEN A WINDOW OUT ON THE EAST SIDE OF HIS HOUSE. HE WAS UNSURE WHAT SHE HIT HIS WINDOW WITH BUT CONFIRMED THAT JOHNSON WAS RESPONSIBLE. OFFICERS PUT OUT A BROADCAST AND CIRCULATED THE AREA FOR THE SUSPECT WITH NEGATIVE RESULTS.
