NARRATIVE

I RESPONDED TO REFERENCED LOCATION FOR A POSSIBLE TERRORISTIC ACT. UPON ARRIVAL, I MADE CONTACT WITH DAMION MCDOWELL. MR MCDOWELL ADVISED HE AND SOME FRIENDS CAME TO THE LOCATION TODAY TO HELP HIS SISTER, YORLANDA MCDOWELL, MOVE TO ANOTHER RESIDENCE. MR MCDOWELL ADVISED UPON ARRIVAL, HE FOUND THE HOUSE TO HAVE SEVERAL BULLET HOLES. I OBSERVED AND TOOK PHOTOS OF THE BULLET HOLES. THERE WERE APPROXIMATELY 10 BULLET HOLES LOCATED ON AND IN THE HOUSE. I LOCATED 3 SHELL CASINGS IN THE STREET. THE CASINGS WERE COLLECTED USING RUBBER GLOVES AND PLACED IN AN ENVELOPE TO BE STORED AS EVIDENCE. MR MCDOWELL ADVISED THE FRONT DOOR FRAME WAS DAMAGED AND THE SUSPECT MAY HAVE ENTERED THE PREMISES. I OBSERVED THE COMPROMISED DOOR FRAME, BUT FOUND NO EVIDENCE OF ENTRY FROM THE SUSPECT. MR MCDOWELL ADVISED NOBODY WAS IN THE HOUSE AT THE TIME OF INCIDENT.
