### **NARRATIVE**

OFFICERS WERE DISPATCHED TO A SHOTS FIRED CALL AT 5320 TIMBERLAND DR. OFFICERS MADE CONTACT WITH THE RESIDENTS AT THE LISTED LOCATION AND THEY ADVISED THEIR HOUSE HAD BEEN SHOT UP. MS RODGERS IS THE OWNER OF VEH-1. MS ARMSTRONG ADVISED AFTER THE SHOTS WERE FIRED, SHE OBSERVED ONE OF THE SUSPECTS RUNNING TO A SEDAN. GET IN, AND FLEE THE SCENE. NO ONE ELSE SAW ANYTHING DURING THE INCIDENT.

WHEN TALKING TO MS ARMSTRONG, SHE ADVISED SHE CALLED OFFICERS EARLIER TO MAKE A SUSPICIOUS PERSON'S REPORT AT APPROXIMATELY 1100 HOURS ON 11/17/2023. NATHAN SPURGEON WAS ASKED IF HE NEEDED ANY MEDICAL ATTENTION MULTIPLE TIMES AND HE DECLINED EACH OFFER. OFFICERS ATTEMPTED TO LOCATE THE FEMALE IN THE AREA, BUT THEY WERE UNABLE TO LOCATE HER. OFFICERS ALSO MADE A RADIO BROADCAST IN REFERENCE TO "KEKE".

### **NARRATIVE**

OFFICERS RESPONDED TO A SHOTS FIRED CALL AT THE LISTED ADDRESS. OFFICERS MADE CONTACT WITH JALEN WOODS. MR. WOODS ADVISED HE WAS MAKING A BOTTLE IN THE KITCHEN FOR HIS NEPHEW J2, WHEN HIS BROTHER, MALIK WOODS, BECAME IRATE AND TOLD HIM, "MAKE YOUR MOVE," WHILE BRANDISHING A PISTOL. MR. JALEN ADVISED HE TOLD MR. WOODS HE DIDN'T KNOW WHAT HE WAS TALKING ABOUT. MR. JALEN ADVISED MR. WOODS WALKED OUTSIDE, REPEATING THE PHRASE FROM BEFORE, BEFORE AIMING THE PISTOL AT MR. JALEN AND FIRING A SHOT. THE BULLET ENTERED A WINDOW TO THE BOTTOM RIGHT OF THE FRONT DOOR AND ENTERED A COUCH THAT WAS IN THE LIVING ROOM OF THE HOME. MR. JALEN ADVISED HIS BROTHER LEFT ON FOOT, WALKING SOUTHBOUND ON GLENMERE.

OFFICERS MADE CONTACT WITH DENISE HARRIS. MS. HARRIS IS THE MOTHER OF JALEN AND MALIK WOODS. MS. HARRIS ADVISED SHE WAS ASLEEP WHEN SHE WAS WOKEN UP BY AN ARGUMENT BETWEEN HER SONS, WHEN SHE HEARD A GUN SHOT. MS. HARRIS ADVISED SHE DID NOT SEE MR. WOODS FIRE THE GUN. MR. JALEN ADVISED THERE WERE TWO JUVENILES OF VERY YOUNG AGE IN THE HOME WHEN MR. WOODS FIRED THE PISTOL.

OFFICERS INSPECTED THE HOME FOR THE BULLET AND FOUND WHAT APPEARED THE BE THE BULLET UNDERNEATH A COUCH INSIDE THE LIVING ROOM. OFFICERS OBSERVED THE COUCH AND LOCATED TWO HOLES WHICH THE RESIDENTS ADVISED WERE NOT THERE PRIOR TO THIS INCIDENT. OFFICERS WERE UNABLE TO LOCATE ANYTHING INSIDE THE COUCH. OFFICERS INSPECTED THE AREA AROUND WHERE MR. WOODS WAS STANDING, ACCORDING TO MR. JALEN, WHEN HE FIRED THE PISTOL, AND WERE UNABLE TO LOCATE THE SHELL CASING. OFFICERS ALSO INSPECTED THE DRIVEWAY NEAR THE ROAD IN CASE THE SHELL CASING ROLLED DOWN THE DRIVEWAY, OFFICERS HAD NEGATIVE RESULTS.

OFFICERS COMPLETED A LETHALITY FORM AS WELL AS PROVIDED A LAURA'S CARD AND AN INCIDENT NUMBER. OFFICERS ADVISED THE FAMILY TO SEEK AN EVICTION NOTICE DUE TO MR. WOODS LIVING AT THE HOME, AS WELL AS TO SEEK AN ORDER OF PROTECTION AND WARRANTS FOR MR. WOODS. OFFICERS SPOKE WITH THE MOTHER OF J2 WHO REFUSED TO BE IDENTIFIED.

SGT. STANGE AND MAJOR CRIMES WERE NOTIFIED. A BROADCAST WAS MADE. MAJOR CRIMES DID NOT RESPOND, BECAUSE THEY WERE TOO BUSY. THE BULLET FRAGMENT WAS STORED AS EVIDENCE AT THE NORTHWEST SUBSTATION.
