### NARRATIVE

OFFICERS RESPONDED TO 5223 SOUTH UNIVERSITY AVENUE IN REFERENCE TO A ROBBERY. CONTACT WAS MADE WITH, CIARA BUTLER, WHO ADVISED AN UNKNOWN BLACK MALE ENTERED THE BUSINESS, SELECTED TWO (2) THIRTY (30) PACKS OF BUD LITE BEER, AND EXITED THE BUSINESS WITHOUT PAYING, PASSING ALL POINTS OF SALE. WHILE ATTEMPTING TO RETRIEVE THE BEER, THE SUSPECT FOUGHT MANAGER, NEIL JEFFERY, AT PUMP 2. MR. JEFFERY ADVISED HE WAS STRUCK IN HIS MOUTH BY THE SUSPECT. I OBSERVED A RAISED AREA AT MR. JEFFERY'S LEFT CHEEK AREA AND I OBSERVED HIS LIP WAS SWOLLEN. HE ADVISED MEDICAL WAS NOT REQUIRED. VIDEO FOOTAGE SHOWS THE SUSPECT ARRIVING IN THE LISTED VEHICLE AT PUMP 2 AT APPROXIMATELY 0937 HOURS. HE EXITED THE VEHICLE, ENTERED THE BUSINESS, SELECTED BEER, AND EXITED THE BUSINESS WITHOUT PAYING. HE APPROACHED THE PASSENGER SIDE OF THE VEHICLE WITH THE BEER, MR. JEFFERY WAS ALREADY OUTSIDE BUT WAS AND WAS ALERTED OF THE THEFT BY MS. BUTLER. WHEN MR. JEFFERY ATTEMPTED TO RETRIEVE THE BEER, A STRUGGLE ENSUED, AND THE SUSPECT IS SEEN PUNCHING MR. JEFFERY IN THE FACE. MR. JEFFERY AND THE SUSPECT FELL TO THE GROUND. THE SUSPECT GOT UP FROM THE GROUND ENTERED THE DRIVER SIDE OF THE VEHICLE AND FLED NORTHBOUND ON SOUTH UNIVERSITY AVENUE. THE SUSPECT WAS WEARING A RED HAT WHICH FELL FROM HIS HEAD DURING THE STRUGGLE. MR. JEFFERY IS SEEN THROWING THE HAT INTO A TRASH CAN CLOSE TO PUMP 2.
