NARRATIVE

ON TODAY'S DATE, OFFICERS WERE DISPATCHED TO THE LISTED ADDRESS FOR A THEFT CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH YERENA, AN EMPLOYEE OF THE BUSINESS. YERENA ADVISED AN UNKNOWN W/M SUSPECT HAD ENTERED THE STORE ASKING FOR "DOPE" ITEMS THAT THE STORE DID NOT CARRY.

YERENA ADVISED THE SUSPECT REQUESTED HIM TO GET A DIGITAL SCALE FROM THE LOCKED GLASS COUNTER AND THE SUSPECT GRABBED A LIGHTER AND A "ONE HITTER" GLASS PIPE. YERENA ADVISED WHEN HE BEGAN TO CHECK THE ITEMS OUT, THE SUSPECT GRABBED ALL OF THE ITEMS, STATED "I HAVE A GUN," AND FLED FROM THE STORE ON FOOT IN AN UNKNOWN DIRECTION OF TRAVEL. YERENA ADVISED THE SUSPECT WAS CARRYING A LARGE RED BOX WITH A CHAINSAW INSIDE OF IT AND THE SUSPECT APPEARED TO BE HOMELESS.

YERENA ADVISED HE WAS UNABLE TO VIEW THE VIDEO FOOTAGE FROM THE INCIDENT AT THIS TIME. OFFICERS OBSERVED THE STORE HAD CONTINUED TO CONDUCT BUSINESS AFTER THIS INCIDENT. YERENA ADVISED HE DID NOT OBSERVE A GUN AT THIS TIME.

OFFICERS NOTIFIED SGT. TOBLER OF THIS INCIDENT. THE AREA WAS SEARCHED WITH NEGATIVE RESULTS FOR THE SUSPECT.
