NARRATIVE

ON TODAYS DATE, COMMUNICATIONS RECEIVED A CALL IN REGARDS TO A SHOOTING THAT JUST OCCURRED.

UPON ARRIVAL OFFICERS NOTICED A CROWD OF CIVILIANS STANDING BY A BLACK MALE LAYING ON THE GROUND. OFFICERS ALSO NOTICED A WITNESS APPLYING PRESSURE TO VICTIM 1(V1) WOUNDS. OFFICERS THEN NOTIFIED COMMUNICATIONS THE SCENE WAS "SECURE FOR MEDICAL."

OFFICERS SPOKE WITH V1 WHO STATED A SUSPECT GOT OUT OF A GRAY SUV AND BEGAN FIRING A HANDGUN AT HIM STRIKING HIM AN UNKNOWN AMOUNT OF TIMES. UPON BEING STRUCK BY GUNFIRE V1 COLLAPSED TO THE GROUND, UNABLE TO RUN. V1 STATED THE SUSPECT HAD CHASED HIM WITH A HANDGUN WHILE FIRING THE WEAPON AT HIM. V1 ALSO STATED THE SUSPECT WAS WEARING A DARK COLORED HOODIE, AS WELL AS A WHITE CLOWN MASK. V1 STATED THE SUSPECT GOT BACK INTO THE SUSPECT VEHICLE. V1 STATED HE ALSO SAW A BLACK FEMALE, WHO HE KNEW TO BE SIMONE COLEMAN, GET INTO THE SUSPECT VEHICLE AND DRIVE OFF WITH TWO UNKNOWN SUSPECTS.

THE FIRE DEPARTMENT, SQUAD 15, ARRIVED ON SCENE AND BEGAN LIFESAVING MEASURES FOR V1 UNTIL MEMS COULD ARRIVE.

OFFICERS THEN CONTACTED A NORTHWEST SUPERVISOR AND REQUESTED A RESPONSE TO THE LOCATION AS WELL AS MAJOR CRIMES DETECTIVES AND THE CRIME SCENE UNIT.

DETECTIVES ARRIVED ON SCENE AND TOOK OVER THE INVESTIGATION.

MEMS, TRUCK 428, ARRIVED ON SCENE AND BEGAN ADMINISTERING THE REQUIRED STEPS TO GET V1 TO THE HOSPITAL.

WHILE GATHERING INFORMATION FOR THE REPORT, IT WAS DISCOVERED THAT APARTMENT 284 WAS STRUCK BY GUNFIRE. UPON TRYING TO MAKE CONTACT WITH THE RESIDENTS OF APARTMENT 284, IT WAS FOUND TO BE OCCUPIED BY THREE VICTIMS INSIDE THE RESIDENCE AT THE TIME IT WAS STRUCK BY GUNFIRE. THE RESIDENCE WAS STRUCK MULTIPLE TIMES IN THE LIVING ROOM OF THE APARTMENT. NONE OF THE VICTIMS WERE STRUCK BY GUNFIRE.

OFFICERS NOTICED A GRAY CADILLAC CTS WITH A BULLET HOLE IN THE FRONT DRIVER SIDE QUARTER PANEL WHICH THEN WENT THROUGH THE TIRE CAUSING IT TO GO FLAT.

WHILE GUARDING THE CRIME SCENE, OFFICERS OBSERVED A BULLET HOLE INSIDE OF APARTMENT 185. OFFICERS ATTEMPTED TO MAKE CONTACT WITH ANYONE INSIDE THE APARTMENT BUT WERE UNSUCCESSFUL. DUE TO THE POSSIBILITY TO SOMEONE BEING STRUCK BY GUNFIRE ON THE INSIDE OF THE APARTMENT IN NEED OF IMMEDIATE MEDICAL ATTENTION, OFFICERS WERE ABLE TO MAKE ENTRY INTO HE APARTMENT DUE THE DOOR BEING UNLOCKED. OFFICERS THEN CLEARED THE APARTMENT FINDING IT TO BE EMPTY WITH NO VICTIMS INSIDE. WHILE CLEARING THE APARTMENT, OFFICERS NOTICED A BULLET HOLE IN THE WALL OF THE FRONT ROOM AS WELL AS EVIDENCE OF THE BULLET STRIKING A WALL IN THE DINING ROOM.

AN OFFICER THEN RESPONDED TO BAPTIST EMERGENCY ROOM WHERE MEMS HAD TRANSPORTED V1 AND WAS TOLD BY MEDICAL STAFF THAT IT APPEARS HIS WOUNDS WERE NOT LIFE THREATENING AT THIS TIME.

OFFICERS THEN HAD WITNESS 1 SIT IN A PATROL VEHICLE AWAY FROM ANY OTHER PERSON UNTIL DETECTIVES WOULD BE ABLE TO INTERVIEW HIM.

CRIME SCENE ARRIVED AND PROCESSED THE SCENE.

A CRIME SCENE LOG WAS MAINTAINED OF ALL PERSONNEL ENTERING THE CRIME SCENE. THIS LOG WAS THEN RELINQUISHED TO THE CRIME SCENE TECHNICIAN.

NARRATIVE

OFFICERS RESPONDED TO THE ABOVE LISTED LOCATION DUE TO A BURGLARY. UPON ARRIVAL OFFICERS MADE CONTACT WITH FAMILY DOLLAR EMPLOYEE, JANIJSHA ARGUE, WHO ADVISED THEY WERE JUST ROBBED AT GUN POINT. SHE ADVISED OFFICERS HE HAD GLOVES ON. SHE ADVISED THE SUBJECT WALKED IN THE FRONT DOOR POINTED A GUN AT THE OTHER EMPLOYEE, JESSICA WILLIAMS, AND FORCED HER TO OPEN THE CASH REGISTER WITH THE GUN POINTED AT HER HEAD. MS. WILLIAMS ADVISED WHEN SHE SHOWED HIM THERE WAS NO MONEY IN THE REGISTER, HE FORCED HER TO TAKE HIM TO THE MANAGERS OFFICE. MS. WILLIAMS ADVISED HE TOLD HER TO KNOCK ON THE OFFICE DOOR AND HE TOLD MS. ARGUE TO LET HIM INSIDE. MS. WILLIAMS ADVISED HE THEN TOLD HER TO GET ON HER KNEES AND TO GET UNDER THE DESK. MS. ARGUE ADVISED HE THEN TOLD HER TO OPEN THE SAFE WHERE HE STOLE APPROXIMATELY \$1300. MS. ARGUE ADVISED HE THEN ATTEMPTED TO MAKE HER OPEN THE BOTTOM DRAWER BUT ADVISED HIM THEY DIDN'T HAVE ACCESS. MS. WILLIAMS ADVISED HE THEN MADE HER TELL THE NEW CUSTOMERS THAT WALKED INSIDE, THE STORE WAS CLOSED. MS. WILLIAMS ADVISED HE RAN OUT THE DOOR, AFTER THE CUSTOMERS LEFT AND RAN WEST BOUND ON W 65TH ST.
