NARRATIVE

OFFICERS WERE CALLED TO THE LISTED LOCATION IN REFERENCE TO A CHECK SUBJECT CALL INVOLVING JUVENILE 2 WHO HAD APPARENTLY BEEN LEFT ALONE IN THE APARTMENT. CONTACT WAS MADE WITH PORCHA OGBULANKWO. SHE ADVISED THAT HER DAUGHTER (JUVENILE 2) WAS OK AND DID NOT NEED ANY MEDICAL ATTENTION. OFFICERS OBSERVED JUVENILE 2 WALKING AROUND IN THE APARTMENT. OFFICERS WERE THEN ADVISED TO CHECK ON ANOTHER CHILD (JUVENILE 1) WHO WAS TAKEN TO CHILDREN'S HOSPITAL AND ADMITTED DUE TO A FENTANYL OVERDOSE. CONTACT WAS MADE WITH CHINYERE OGBULANKWO (JUVENILE 1 MOTHER). SHE ADVISED THAT SHE WAS AT PORCHA'S APARTMENT ALONG WITH JUVENILE 1 AND 2 WHEN JUVENILE 1 STARTED HAVING PROBLEMS BREATHING. SHE SAID SHE THOUGHT SHE WAS CHOKING ON A CHICKEN BONE. CHINYERE SAID SHE THEN TOOK JUVENILE 1 TO THE HOSPITAL. CONTACT WAS MADE WITH SHE SOCIAL WORKER (STEPHANIE MEINCKE). SHE SAID THE CHILD WAS BROUGHT IN AROUND 0307 HOURS AND JUVENILE 1 WAS ADMINISTERED ONE DOSE OF NARCAN BEFORE SHE WOKE UP. SHE ADVISED THAT CHILD WAS IN STABLE CONDITION AT THIS TIME. SGT. TINER WAS NOTIFIED OF THE INCIDENT. MAJOR CRIME DETECTIVES RESPONDED ON SCENE AT THE HOSPITAL. CHINYERE WAS TAKEN INTO CUSTODY AND TRANSPORTED TO 12TH STREET D.O. FOR QUESTIONING. PORCHA WAS ALSO TRANSPORTED FOR QUESTIONING. CHINYERE WAS FOUND TO HAVE A NO -CONTACT ORDER WITH JUVENILE 1 THAT IS STILL IN PLACE.

MEINCKE ADVISED THAT SHE CALLED THE CHILD ABUSE HOTLINE. (REF.#2242054) CONTACT WAS ALSO MADE WITH J. AARON GOSSETT (SENIOR INVESTIGATOR CRIMES AGAINST CHILDREN) FOR THE STATE POLICE. CHINYERE WAS SUBSEQUENTLY CHARGED WITH EXPOSING A PERSON TO FENTANYL, ENDANGERING THE WELFARE OF A MINOR 1ST AND VIOLATION OF A NO CONTACT ORDER. PORCHA WAS SUBSEQUENTLY CHARGED WITH EXPOSING A PERSON TO FENTANYL AND ENDANGERING THE WELFARE OF A MINOR. BWC WAS IN USE.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A ROBBERY OF A BUSINESS THAT JUST OCCURRED. UPON ARRIVAL, OFFICERS MADE CONTACT WITH AN EMPLOYEE MR. OGLESBY. HE STATED HE WAS THE ONLY EMPLOYEE IN THE STORE PREPARING TO CLOSE THE STORE. MR. OGLESBY ADVISED A BLACK MALE WEARING YELLOW AND BLACK PLAID LONG SLEEVE SHIRT WITH KHAKI COLORED PANTS WALKED INTO THE STORE. HE STATED HE TOLD THE MALE SUBJECT HE HAD 4 MINUTES TO PURCHASE THE ITEMS HE WANTED. MR. OGLESBY ADVISED THE MALE ASKED FOR A BLACK&MILD. MR. OGLESBY THEN TOLD THE MALE HE WOULD NEED UNLOCK A SECURE CASE TO ACQUIRE THAT ITEM. HE STATED WHEN HE TURNED AROUND AFTER ACQUIRING THE BLACK&MILD OUT OF THE LOCKED CASE THE SUSPECT HAD HIS HAND UNDERNEATH HIS SHIRT MAKING GESTRUING LIKE HE HAD A FIREARM UNDER HIS CLOTHING. MR. OGLESBY ADVISED THE SUSPECT DEMANDED HIM TO OPEN THE CASH REGISTER AND GIVE HIM THE MONEY. HE STATED HE GRABBED THE MONEY WALKED FROM BEHIND THE COUNTER, AND DECIDED HE WASN'T GOING TO GIVE THE SUSPECT THE MONEY SO EASILY. MR. OGLESBY STATED THEY STARTED TUSSLING OVER THE MONEY AND ONE OF THE TWENTY DOLLAR BILLS RIPPED IN HALF. HE ADVISED THE SUSPECT FLED NORTHBOUND ON FOOT BEHIND THE BUSINESS.
