## **NARRATIVE**

THIS REPORT WAS TAKEN BY PHONE DUE TO THE VICTIM CALLING FROM OUT OF TOWN AFTER RETURNING HOME. COFFMAN ADVISED HE STOPPED AT THE SHELL AT 9TH AND I30 FOR GAS. HE POPPED THE TRUNK TO HIS BLACK HONDA FIT TO RETRIEVE HIS WALLET. WHILE DOING SO A BLACK MALE WEARING A BLACK COAT AND BLACK BALLCAP WITH GREEN AND RED WRITING APPROACHED HIM. THE SUBJECT ASKED COFFMAN IF HE HAD ANY MONEY TO HELP OUT HIS MOTHER. COFFMAN ADVISED HE DID NOT. THE SUSPECT PULLED UP HIS SHIRT REVEALING A KNIFE TUCKED IN THE WAISTBAND. ## NARRATIVE

29 OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A BATTERY REPORT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH VICTIM 1 (SHELTON).

VICTIM 1 (SHELTON) ADVISED: SHE WAS IN A PHYSICAL DISTURBANCE WITH HER SON (SUSPECT 1) (DAVIS). VICTIM 1 STATED THAT SUSPECT 1 HAD BEEN ACTING WEIRD AND ASKED TO GET OUT OF THE HOUSE AND GO TO HIS FRIENDS HOUSE. VICTIM 1 ADVISED SHE TOOK SUSPECT 1 TO HIS FRIENDS HOUSE AND HE REFUSED TO GET OUT OF THE CAR. WHEN ASKED WHY HE WOULDN'T GET OUT VICTIM 1 WAS TOLD BY SUSPECT 1 THAT HE DIDN'T AND TO JUST SIT THERE. VICTIM 1 AND SUSPECT 1 THEN GOT INTO A VERBAL ALTERCATION IN WHICH VICTIM 1 ACCUSED SUSPECT 1 OF WANTING TO JUST RIDE AROUND.

VICTIM AND SUSPECT 1 THEN RETURNED HOME AND SHE PARKED HER CAR IN THE DRIVEWAY. VICTIM 1 STATED SUSPECT 1 GOT OUT OF THE CAR, WALKED AROUND THE CAR TO THE DRIVER SIDE, AND OPENED THE DOOR. WHEN SUSPECT 1 OPENED THE DOOR, VICTIM 1 ASKED WHAT HE WAS DOING. VICTIM 1 ADVISED SUSPECT 1 SAID, "GIVE ME THE KEYS, FAM." VICTIM 1 REFUSED TO GIVE SUSPECT 1 HER KEYS. VICTIM 1 NOTICED THAT SUSPECT 1 WAS HOLDING AN UNKNOWN BLACK PISTOL IN HIS HAND, DOWN AT HIS SIDE.

VICTIM 1 EXITED THE CAR, AT WHICH TIME SUSPECT 1 ATTEMPTED TO PHYSICALLY TAKE HER KEYS THAT WERE ATTACHED TO HER PURSE. DURING THE ALTERCATION SUSPECT 1 BROKE VICTIM 1'S PURSE. VICTIM 1 ATTEMPTED TO RUN INTO HER HOME, BUT SUSPECT 1 GRABBED HER AND THREW HER ON THE GROUND IN FRONT OF THE HOME. VICTIM 1 THEN GOT UP AND WAS CORNERED AT THE EDGE OF THE YARD, WHERE SUSPECT MADE HER BELIEVE HE WAS GOING TO THROW HER OFF THE RETAINING WALL.

VICTIM 1 AND SUSPECT 1 WERE THEN IN ANOTHER ALTERCATION WHERE SHE WAS THROWN DOWN AGAIN AND SUSPECT 1 WAS ABLE TO GET HER KEY. VICTIM 1 THEN ATTEMPTED TO CALL 911 ON HER CELL PHONE, BUT SUSPECT 1 TOOK HER PHONE AND THREW THE PHONE AGAINST HER WINDOW, BREAKING THE PHONE AND THE WINDOW. SUSPECT 1 THEN JUMPED IN VICTIM 1'S CAR AND LEFT THE LOCATION.

NO PHYSICAL INJURY WAS OBSERVED BY OFFICERS ON VICTIM 1.
