JUVENILE INFORMATION

NARRATIVE

OFFICERS WENT TO 4424 W. 27TH STREET FOR A SHOTSPOTTER ACTIVATION, ONE ROUND, AND 11 ROUNDS. UPON ARRIVAL, OFFICERS OBSERVED SEVERAL INDIVIDUALS STANDING OVER A BLACK MALE WHO WAS FACING DOWN ON THE SIDEWALK. OFFICERS ASKED IF THE MALE WAS SHOT, AND EVERYONE ADVISED YES. OFFICERS ROLLED THE MALE OVER AND OBSERVED A LARGE AMOUNT OF BLOOD COMING FROM HIS LOWER ABDOMEN AREA. OFFICERS THEN ASKED THE GROUP OF INDIVIDUALS IF THEY KNEW WHO SHOT HIM. NICOLE ROBINSON STATED SHE SAW A DARK SKIN MALE LEAVE ON FOOT AND GET INTO A DARK-COLORED CAR. OFFICERS ROLLED THE BLACK MALE VICTIM OVER AND TOOK HIS BLACK BACKPACK OFF HIS BACK. OFFICERS THEN CHECKED THE VICTIM'S BODY FOR GUNSHOT WOUNDS BUT WERE NOT ABLE TO SEE THE WOUND DUE TO THE AMOUNT OF COAGULATED BLOOD IN HIS PANTS. RESCUE ARRIVED ON THE SCENE AND BEGAN TO RENDER AID TO THE BLACK MALE, WHO THEY ADVISED DID NOT HAVE A PULSE. THE VICTIM DID NOT HAVE A WALLET OR ANY FORM OF IDENTIFICATION ON HIM.

OFFICERS CHECKED HIS BACKPACK AND LOCATED A DEBIT CARD WITH THE NAME BRAD CURRY ON IT. OFFICERS ASKED BRANDON DONOVAN, WHO WAS STANDING ON THE FRONT PORCH IF HE SAW ANYTHING. BRANDON STATED HE WAS DOWN THE STREET, HEARD THE SHOTS, AND CAME OVER. BRANDON AND THE HOMEOWNER, GREGORY NICHOLS, CONFIRMED THAT THE VICTIM'S NAME WAS BRAD. OFFICERS THEN CONDUCTED A SEARCH ON ATLAS AND CONFIRMED THE VICTIM WAS BRAD CURRY. GREGORY TOLD OFFICERS THAT HE WAS IN THE HOUSE AND HEARD PEOPLE TALKING OUTSIDE. HE THEN HEARD 1 SHOT, OPENED HIS FRONT DOOR, AND LOOKED OUTSIDE. HE SAW A BLACK MALE WITH AN ASSAULT RIFLE STANDING OVER BRAD CURRY'S BODY. THE SUSPECT THEN POINTED THE RIFLE AT GREGORY. GREGORY IMMEDIATELY CLOSED THE DOOR AND GOT DOWN ON THE GROUND. THE SUSPECT BEGAN SHOOTING WHILE GREGORY WAS SHUTING THE DOOR. NOBODY WAS STRUCK EXCEPT GREGORY'S DOG THAT WAS DECEASED.

OFFICERS THEN CLEARED THE HOUSE FOR ANY OTHER VICTIMS AND LOCATED AMBER THOMAS IN THE BACK ROOM. AMBER STATED SHE WAS SLEEPING ON THE COUCH WHEN THE SHOTS WERE FIRED. OFFICERS ADVISED HER TO COME OUTSIDE THE HOUSE DUE TO THE HOUSE BEING A CRIME SCENE. OFFICERS THEN EXITED THE HOUSE AND BEGAN PUTTING CRIME SCENE TAPE AROUND THE CRIME SCENE. OFFICERS THEN MADE CONTACT WITH CHRIS FORD AND EMILY GARZA, WHO STATED THEY WERE ALSO INSIDE THE HOUSE WHEN THE SHOTS WERE FIRED. THE ENCOUNTER LEAD TO AN USE OF FORCE WITH CHRIS. SEE INCIDENT NUMBER 2023-141869 FOR THE USE OF FORCE. BRAD WAS THEN TRANSPORTED TO UAMS BY MEMS. OFFICERS THEN STOOD BY UNTIL THE DETECTIVES AND CSSU ARRIVED ON THE SCENE. NO CASINGS WERE FOUND, BUT THERE WERE A LARGE AMOUNT OF LIVE 22 CALIBER ROUNDS ON THE SIDEWALK WHERE BRAD WAS LYING. WHILE STANDING BY WITH CSSU, OFFICERS OBSERVED 1 LIVE 22 CALIBER ROUND LIKE THE ONES OUTSIDE INSIDE THE RESIDENCE. CSSU FINISHED PROCESSING THE CRIME SCENE, AND NO FURTHER POLICE ACTIONS WERE TAKEN. BWC/MVR WAS IN USE.

On December 9, at approximately 0640 hours, victim Brad Curry succumbed to his injuries. The next of kin was notified.
