## **NARRATIVE**

ON THE LISTED INCIDENT DATE, OFFICERS STEWART, PITTS, AND SIMS WERE WORKING IN AN OFF-DUTY CAPACITY AT THE LISTED INCIDENT ADDRESS. AT APPROXIMATELY 0206 HOURS, OFFICERS MADE CONTACT WITH VICTIM #1, MS. WILLIAMS, AFTER SHE WAS DENIED RE-ENTRY INTO THE ESTABLISHMENT BY INTERNAL SECURITY DUE TO HER CAUSING A DISTURBANCE. OFFICERS ESCORTED MS. WILLIAMS TO THE PARKING LOT OF THE ESTABLISHMENT. DURING THIS INTERACTION WITH MS. WILLIAMS, OFFICER STEWART EMPLOYED THE USE OF OC SPRAY. MS WILLIAMS WAS SUBSEQUENTLY TRANSPORTED TO HER PLACE OF RESIDENCE BY OFFICERS PITTS AND SIMS. AT A LATER DATE, MS.
