#### **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL IN PROGRESS. UPON ARRIVAL, THERE WERE EMPLOYEES STANDING OUTSIDE POINTING AT A WHITE MALE IN ALL GRAY ATTEMPTING TO RUN FROM THE SCENE. THE WHITE MALE WAS LATER IDENTIFIED AS DUSTIN MORROW. OFFICERS PUT MR. MORROW AT GUN POINT AND GAVE HIM COMMANDS TO LAY DOWN ON THE GROUND. MR. MORROW WAS TAKEN INTO CUSTODY WITHOUT INCIDENT. OFFICERS COULD SMELL A STRONG ODOR OF INTOXICANTS ON MR. MORROW'S BREATH. OFFICERS ASKED MR. MORROW WHAT HAPPENED, HE STATED HE WAS ATTEMPTING TO GET HIS CAR BACK. OFFICERS ASKED HIM WHAT TYPE OF CAR, AND HE STATED A 2017 TOYOTA HIGHLANDER. THE VEHICLE INVOLVED WAS A MAROON 2023 DODGE CHARGER. MR. MORROW REFUSED MEDICAL ATTENTION.

OFFICERS MADE CONTACT WITH MR. HOWARD, WHO IS THE OWNER OF THE LISTED VEHICLE. HE STATED HE SEEN MR. MORROW WALKING OUT IN THE COUNTY, SO HE STOPPED AND GAVE HIM A RIDE. MR. HOWARD STATED HE DROVE TO A LOT OF DIFFERENT PLACES FOR MR. MORROW, AND IT WAS TIME FOR HIM TO GO TAKE CARE OF SOME BUSINESS FOR HIMSELF. HE ADVISED HE STOPPED AT THIS LOCATION TO LET MR. MORROW OUT OF HIS VEHICLE AND HE REFUSED TO GET OUT. MR. HOWARD STATED MR. MORROW MADE THE COMMENT "WHEN YOU GET OUT I'LL GET OUT". HE ADVISED WHEN HE STEPPED OUT OF THE CAR MR. MORROW CRAWLED OVER THE CENTER CONSOLE ATTEMPTING TO TAKE HIS CAR. MR. HOWARD STATED HE HAD TO PHYSICALLY FIGHT MR. MORROW TO GAIN CONTROL OVER HIS VEHICLE. HE ADVISED THE ONLY REASON HE DID NOT GET AWAY, BECAUSE HIS VEHICLE WILL NOT MOVE IF IT'S IN GEAR AND THE DOOR IS OPEN. OFFICERS OBSERVED MARKS ON MR. HOWARD'S RIGHT HAND AND FACE. HE REFUSED MEDICAL ATTENTION. MR. HOWARD ADVISED HE NEEDED TO GO SEE HIS MOTHER IN THE NURSING HOME. HE STATED HE DID NOT WANT TO PRESS ANY CHARGES AT THIS TIME. MR. HOWARD WAS PROVIDED WITH THE INCIDENT AN ADVISED HIM A DETECTIVE WOULD POSSIBLY BE IN CONTACT WITH HIM TO FOLLOW UP ON THIS INCIDENT.

MR. MORROW WAS TRANSPORTED TO PCRJ WHERE HE WAS CHARGED WITH PUBLIC INTOXICATION. HE WAS A DANGER TO HIMSELF AN OTHERS. BWC AND MVR IN USE.

A SOUTHWEST SERGEANT WAS NOTIFIED.

#### **NARRATIVE**

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A CRIMINAL MISCHIEF. OFFICERS MADE CONTACT WITH MR. LOPEZ WHO ADVISED HE HAD JUST RETURNED HOME FROM WORK AND FOUND THAT HIS RESIDENCE AND VEHICLE 1 HAD BEEN STRUCK BY GUNFIRE. OFFICERS OBSERVED APPROXIMATELY EIGHT GUNSHOT HOLES IN THE RESIDENCE. OFFICERS ALSO OBSERVED THE REAR WINDSHIELD OF VEHICLE 1 HAD BEEN STUCK BY GUNFIRE. MR. LOPEZ ADVISED OFFICERS THERE WERE FOOTSTEPS IN THE SNOW IN HIS BACKYARD THAT HE DID NOT MAKE, POSSIBLY A SUBJECT WHO HAD BEEN SHOT AT. MR. LOPEZ ADVISED HIS NEIGHBOR, MR. BUTLER, MAY HAVE SEEN THE INCIDENT. OFFICERS MADE CONTACT WITH MR. BUTLER WHO ADVISED HE HEARD THE GUNSHOTS AND WHEN HE WENT TO LOOK OUT THE WINDOW, HE SAW A NEWER MODEL MAROON DODGE CHARGER LEAVING AT A HIGH RATE OF SPEED, WESTBOUND ON MABELVALE PIKE. OFFICERS NOTIFIED A SOUTHWEST SUPERVISOR OF THE INCIDENT, WHO RESPONDED TO THE SCENE. MAJOR CRIMES WAS ALSO NOTIFIED OF THE INCIDENT. OFFICERS DID LOCATE SHELL CASINGS IN THE ROADWAY, WHICH WERE STORED AS EVIDENCE. WHILE COLLECTING THE SHELL CASINGS, OFFICERS WERE APPROACHED BY MR. BUTRAM. MR. BUTRAM HAD SPOKE WITH OFFICERS EARLIER WHEN HE CALLED IN THE SHOTS FIRED, 2024-006078, BUT FOUND HIS RESIDENCE HAD BEEN HIT. THIS SHOTS FIRED IS BELIEVED TO BE WHEN MR. LOPEZ'S RESIDENCE WAS STRUCK. ## **NARRATIVE**

ON JANUARY 17TH OFFICERS RESPONDED TO THE LISTED LOCAITON TO A REPORT OF A SHOTS FIRED IN THE AREA. UPON ARRIVAL OFFICERS MADE CONTACT WITH SEVERAL SUBJECTS OUTSIDE AT THE INCIDENT LOCATION, AND ASKED IF ANY SHOTS HAD BEEN HEARD.

ALL SUBJECTS RESPONDED NO TO THE SHOTS FIRED IN THE AREA.

MR. HARPER WHO WAS STANDING NEAR HIS MOTHER MS. DYER STATED SHE WAS ASSUALTED AFTER BEING STRUCK IN THE MOUTH BY MR. TURNER. AFTER THE STATMENT WAS MADE OFFICERS OBSERVED A MALE SUBJECT ATTEMPTING TO GO INSIDE A NEAR BY APARTMENT, BEFORE FALLING TO THE GROUND. UPON FURTHER INVESTIGATION, OFFICERS NOTICED A LARGE LACERATION TO THE LEFT SIDE OF MR. TURNERS HEAD. AT THE TIME OF CONTACT MR. TURNER REFUSED TO PROVIDE A STATMENT AND MEDICAL ATTENTION. MR. TURNER ULTIMATELY WAS TRANSPORTED BAPTIST FOR FURTHER MEDICAL ATTENTION.

OFFICERS MADE CONTACT WITH MS. DYER JUST OUTSIDE OF HER APARTMENT, WHERE SHE INITALLY STATED SHE STRUCK MR. TURNER WITH BATON. WHEN OFFICERS ASKED WHAT HAPPENED, BEFORE STATING SHE USED A STICK. MS. DYER WAS DETAINED AND TRANSPORTED TO THE 12TH STREET DETECTIVE DIVISION FOR FURTHER QUESTIONING.

OFFICERS MADE CONTACT WITH MR. HARPER, WHO STATED HE WAS SLEEPING DURING THE TIME OF THE DISTURBANCE. MR. HARPER WAS TRANSPORTED TO 12TH DETECTIVE DIVISION.

OFFICERS LATER MADE CONTACT WITH MR. TURNER, WHO STATED HE WAS ATTACKED BY BOTH MS. DYER AND MR. HARPER WHO HAD BLUNT OBJECTS. MR. TURNER SUSTAINED A FRACTURED SKULL AND BRAIN BLEED AT THE RESULT OF THE ATTACK.

OFFICERS MADE CONTACT WITH MS. MATHESS, WHO STATED SHE AND MR. TURNER WERE IN A VERBAL DISTURBANCE BEFORE SHE WENT INSIDE HER RESIDENCE. MS. MATHESS STATED SHE HEARD A SERVEARL SUBJECTS ARGUING BEFORE HEARING WHAT SHE THOUGHT WAS A SINGLE GUNSHOT.

OFFICERS THEN MADE CONTACT WITH MS. MORTON, WHO STATED SHE DID NOT OBSERVE ANYONE BEING ASSAULTED BUT HEARD THEM ARGUING. MS. MORTON STATED AFTER SHE HEARD THE DISTURBANCE, SHE WENT TO GET MR. HARPER TO GET HIS MOTHER MS. DYER.

MR. HARPER STATED HE OBSERVED MR. TURNER STRICKING HIS MOTHER BEFORE PULLING THE TWO APART.

OFFICERS LOCATED A SINGLE CASING NEAR THE INCIDENT LOCATION AND POSSIBLE DAMAGE TO THE CEILING OF THE BALCONY. WHICH WAS STORED AT THE NORTHWEST PROPERTY.

NORTHWEST PATROL SGT AND DETECTIVE WERE NOTIFIED.

MS. DYER REMAINED AT THE 12 STREET DO BEFORE BEING TRANSPORTED TO PCRJ FOR PENDING CHARGES. MVR WAS IN USE.

## **NARRATIVE**

COMMUNICATIONS RECEIVED A CALL OF A BATTERY IN PROGRESS AT THE MURPHY'S USA AT 14701 CANTRELL. WHILE ON MY WAY COMMUNICATIONS ADVISED SUBJECT CAME BACK BUT LEFT AGAIN EAST BOUND ON CANTRELL IN A SILVER JEEP.

ARRIVED AT 14701 CANTRELL AND MADE CONTACT WITH JOSEPH HILL WHO STATED THAT HE HAD A SEVERAL PEOPLE ENTER THE STORE WHO HE KNEW TO STEAL FROM THE BUSINESS. JOSEPH HILL STATED THAT HE WALKED TO THE BEER COOLER AS THE UNKNOWN BLACK MALE SUSPECT WAS WALKING OUT WITH 2 30 PACKS. JOSEPH HILL STOPPED HIM AT THE DOOR TO THE BEER COOLER AND TOLD HIM JUST SIT IT DOWN AND GO. JOSEPH HILL SAID THE UNKNOWN MALE THEN TOOK AN AGGRESSIVE STANCE JOSEPH HILL TOLD HIM TO JUST LEAVE. WHILE GETTING CLOSER TO JOSEPH HILL THE UNKNOWN SUSPECT WAS HOLDING A 30 PACK OF BEER. JOSEPH HILL WAS GIVING VERBAL COMMANDS FOR THE SUBJECT TO STOP BUT HE WOULD NOT. AS THE UNKNOWN SUSPECT RAISED HIS ARM UP AS IF HE WAS GOING TO HIT JOSEPH HILL WITH THE CASE OF BEER JOSEPH HILL DEFENDED HIMSELF. JOSEPH HILL STRUCK THE SUSPECT MULTIPLE TIMES AS THE UNKNOWN SUSPECT WAS ALSO HITTING JOSEPH HILL. THE FIGHT WENT TO THE GROUND WHERE JOSEPH HILL WAS ON TOP CONTROLLING THE UNKNOWN MALE SUSPECT. THE MALE SUSPECT SAID HE WAS GOING TO LEAVE JUST TO LET HIM UP SO AS THE UNKNOWN SUSPECT WAS GETTING UP HE CAME AT JOSEPH HILL. JOSEPH HILL DEFENDING HIMSELF AGAIN PICKED THE UNKNOWN SUSPECT UP AND THREW HIM TO THE GROUND AND GOT BACK ON TOP OF THE MALE SUSPECT. JOSEPH HILL STATED A FEMALE THAT WAS WITH THE UNKNOWN MALE SUSPECT THEN CAME OVER SAYING LET HIM GO AND BEGAN SCRATCHING JOSEPH HILL'S BACK IN AN ATTEMPT TO GET THE UNKNOWN MALE SUSPECT UP. HILL LET THE UNKNOWN MALE SUSPECT LEAVE AND THEY FLED EAST ON CANTRELL IN A MID 2000'S GREY JEEP CHEROKEE WITH NO TAGS.

THEN THE GROUP CAME BACK AND INCLUDED UNKNOWN FEMALE SUSPECT 2. THE FIRST FEMALE STATED THEY WERE MISSING THEIR PHONE. JOSEPH HILL ADVISED HIM HE DID NOT HAVE IT AND ALL PARTIES INVOLVED BEGAN THROWNING ANYTHING THEY COULD GET THEIR HANDS ON DOING DAMAGE TO THE STORE.

JOSEPH HILL SAID POLICE WERE ON THE WAY AND THE UNKNOWN FEMALE 1 STATED IT AIN'T WORTH IT LES GO. ALL SUBJECTS GOT INTO THE JEEP AND FLED AGAIN EAST. AS I ARRIVED ON SCENE ALL SUSPECT WERE GONE AND JOSEPH HILL HAD SOME SCRATCHES AND SMALL ABRASIONS. WE THEN REVIEWED THE VIDEO FOOTAGE AND SEEN UNKNOWN FEMALE 2 COME IN AND WHILE THE OTHERS SHOPPED SHE WALKED OUT WITH 2 BUD LIGHT CASES. UNKNOWN SUSPECT 2 THEN STAYED IN THE VEHICLE WHEN SHE GOT THERE AS TO DRIVE FOR THE OTHER SUSPECTS. SUSPECT 1 PHYSICALLY FOUGHT JOSEPH HILL WHILE TRYING TO STEAL BEER, AND UNKNOWN FEMALE 1 ASSISTED IN ASSAULTING JOSEPH HILL TRYING TO GET THE UNKNOWN SUSPECT SO THEY COULD LEAVE. WHILE ALL THIS IS GOING ON UNKNOWN SUSPECT 2 LEFT THE BUSINESS WITHOUT PAYING FOR THEM. A BROADCAST OF THE SUSPECTS AND VEHICLE WAS MADE AS WELL
