NARRATIVE

ON JANUARY 18, 2024, AT APPROXIMATELY 0133 HOURS, OFFICERS WERE DISPATCHED TO A SHOOTING JUST OCCURRED CALL FOR SERVICE AT THE LOCATION OF 13600 OTTER CREEK PARKWAY. OFFICERS WERE ADVISED THE CALLER HEARD GUNSHOTS AND A SUBJECT WAS SHOT OUTSIDE. OFFICERS ARRIVED AND LOCATED OWEN MITCHELL IN THE BREEZEWAY OF BUILDING 9. MEMS PERSONNEL RESPONDED TO PROVIDE LIFESAVING MEDICAL TREATMENT, BUT MR. MITCHELL WAS PRONOUNCED DECEASED AT THE SCENE. HOMICIDE DETECTIVES AND CSSU PERSONNEL WERE CONTACTED AND RESPONDED. THE PULASKI COUNTY CORONERS OFFICE WAS CONTACTED AND RESPONDED. THE BODY OF MR. MITCHELL WAS TRANSPORTED TO THE ARKANSAS STATE CRIME LAB PENDING AN AUTOPSY. NEXT OF KIN NOTIFICATION IS PENDING.
