OFFICERS RESPONDED TO THE LISTED LOCATION IN RESPONSE TO A THEFT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH AN EMPLOYEE, HALL, WHO ADVISED MULTIPLE BLACK MALES IN MASKS ROBBED THE BUSINESS AT GUNPOINT. OFFICERS OBSERVED THE SUSPECTS WALKING FROM A NEIGHBORHOOD ON THE NORTHEAST CORNER OF THE BUSINESS. OFFICERS THEN OBSERVED THREE BLACK MALES ENTER THE BUSINESS WEARING FACE MASKS AND GLOVES. S1 WAS ARMED WITH A HANDGUN AND IS SEEN THREATENING HALL WITH THE GUN IN THE FOOTAGE. S1 IS THEN SEEN MOVING HALL'S PHONE AWAY FROM HER. THE SUSPECTS BEGIN GRABBING BACKPACKS FROM THE STORE AND FILLING THEM WITH THE LISTED ASSORTED MERCHANDISE.

DURING THE INCIDENT, THREE UNKNOWN VICTIMS OPEN THE DOOR TO THE BUSINESS AND ATTEMPT TO LEAVE WHEN S1 FORCES THEM TO ENTER THE STORE. S1 THEN POINTS THE GUN AT THE THREE UNKNOWN VICTIMS AND ORDERS THEM TO GET ON THEIR KNEES. DURING THIS TIME, THREE SUBJECTS ARE SEEN IN THE FOOTAGE WALKING FROM THE SHOPPING CENTER ON THE WEST SIDE OF UNIVERSITY TO THE FRONT OF THE BUSINESS. THE SUBJECTS MAKE CONTACT WITH S1 WHERE S1 GIVES THEM WHAT APPEARS TO BE MONEY. S1 AND THE SUBJECTS THEN EXCHANGE A HANDSHAKE AND THE SUBJECTS WALK BACK TO THE WEST SIDE OF UNIVERSITY. NARRATIVE

OFFICERS WERE IN THE AREA WHEN THEY WERE FLAGGED DOWN BY TWO UNKNOWN PASSER BYE'S. THE UNKNOWN SUBJECTS ADVISED A BLACK MALE WAS SHOT AND IS LYING ON THE PARKING LOT OF THE FAMILY DOLLAR AT INCIDENT ADDRESS. OFFICERS ARRIVED ON SCENE AND OBSERVED MR. ACKER LYING IN THE PARKING LOT OF THE FAMILY DOLLAR. HE APPEARED TO BE SHOT IN THE BACK. MR. ACKER ADVISED OFFICERS HE WAS DRIVING AND SOMEONE PULLED UP NEXT TO HIM AND SHOT HIM.

MEMS AND RESCUE RESPONDED AND TRANSPORTED MR. ACKER TO BAPTIST HOSPITAL.

MS. COONEY WAS ON SCENE WHEN OFFICERS ARRIVED AND SHE STATED SHE WAS DRIVING SOUTHBOUND ON CHICOT ROAD WHEN SHE OBSERVED VEHICLE-1 CRASHED OFF THE ROADWAY NEXT TO FAMILY DOLLARS PARKING LOT. SHE OBSERVED THE CAR SMOKING AND SHE OBSERVED MR. ACKER GET OUT OF THE DRIVERS SEAT AND FALL TO THE GROUND. SHE STATED SHE OBSERVED A BLACK MALE RUNNING THROUGH THE EXXON PARKING LOT AT THE CORNER OF MABLEVALE CUT OFF AND CHICOT ROAD. SHE STATED THE SUBJECT WAS A BLACK MALE IN HIS EARLY 20'S WITH A RED HOODIE ON AND BLACK PANTS. SHE ADVISED HE HAD A GUN IN HIS HAND. SHE ADVISED HE RAN THROUGH THE EXXON PARKING LOT AND TURNED EASTBOUND ON MABLEVALE CUT OFF FROM CHICOT ROAD ON FOOT. SHE STATED SHE TALKED TO MR. ACKERS WHO ASKED HER TO GO TO HIS HOUSE AND GET HIS MOTHER WHICH SHE DID. SHE DROVE HIS MOTHER, MS. NORTH TO THE SCENE.

MS. NORTH ARRIVED ON THE SCENE AND STATED HER BABY, MR. ACKERS JUST LEFT THE HOUSE WALKING TO THE STORE AND THAT HE COULDN'T HAVE BEEN IN A CAR BECAUSE HE DOESN'T HAVE A CAR.

WHILE OFFICERS WERE SPEAKING TO THE EXXON STORE CLERK, MS. WARREN ARRIVES ON SCENE AND ADVISES OFFICERS A FRIEND OF HERS, MR. BLACKMON (WHO IS EXITING THE CAR WHILE SHES SPEAKING AND PUTS HIS HANDS IN THE AIR) SHOWED UP ON FOOT AT HER HOUSE. SHE STATED MR. BLACKMON TOLD HER THAT HE WENT TO THE EXXON GAS STATION AND LEFT HIS CAR, VEHICLE 1 RUNNING WHILE HE WENT INTO THE STORE TO SEE HOW MUCH SOMETHING COSTS. AS HE EXITED THE STORE AN UNKNOWN SUBJECT GOT INTO VEHICLE 1 AND STOLE IT. MR. BLACKMON PULLED ON THE DOOR HANDLE TRYING TO OPEN IT BUT IT WAS LOCKED AND THE GUY WAS DRIVING OFF SO HE SHOT AT THE CAR AS IT DROVE OFF. SHE TOLD MR. BLACKMON THAT HE HAS TO RETURN TO THE SCENE. SHE CALLS HER FRIEND, MS. WILLIAMS WHO IS ALREADY ON HER WAY TO THE HOUSE BECAUSE NO ONE AT HER HOUSE HAS A CAR. MS. WILLIAMS ARRIVES AT MS. WARRENS HOME AND PICK HER UP ALONG WITH MR. BLACKMON. THEY ALL LOAD UP IN HER CAR AND RETURN TO THE SCENE.

MS. WILLIAMS ADVISES OFFICERS THAT THE GUN USED IN THE CRIME IS LAYING ON HER TRUNK. OFFICERS TAKE MR. BLACKMON INTO CUSTODY AND RECOVER THE GUN.

COMMUNICATIONS ADVISED THEY RECEIVED A PHONE CALL FROM MS. FRICKS STATING SHE WAS AT THE INTERSECTION OF MABLEVALE CUT OFF AND CHICOT ROAD WHEN SHE HEARD MULTIPLE GUN SHOTS. SHE CONTINUED OUT OF THE AREA TO MURRYS DINNER PLAYHOUSE AT 6323 COLONEL GLENN ROAD. WHEN SHE GOT OUT OF HER CAR, VEHICLE 2, SHE NOTICED A BULLET HOLE ENTER THROUGH THE REAR DRIVERS SIDE CORNER PANEL AND EXIT THE OPPOSITE SIDE. OFFICERS RESPONDED TO HER LOCATION AND TOOK HER STATEMENT.

SGT.JORDAN WHITE AND SGT. BRITTNEY JACKSON RESPOND TO THE SCENE. DETECTIVE SGT. DAMON WHITNER RESPONDS AND DETECTIVE SARAH HICKS RESPONDED. CSSU RESPONDED AND PROCESSED THE SCENE. ASHER WRECKER RESPONDED AND TOWED VEHICLE 1 TO THE CRIME SCENE BAY.
