NARRATIVE

OFFICER'S RESPONDED TO A SHOOTING IN PROGRESS AT THE CIRCLE K AT ASHER AND UNIVERSITY. UPON OFFICER'S ARRIVAL THEY LOCATED SUSPECT 1 (BLACKWELL), WHO WAS STILL ARMED AND WAS TAKEN INTO CUSTODY. THEY THEN LOCATED TWO INDIVIDUALS WHO WERE SUFFERING FROM APPARENT GUNSHOT WOUNDS, THEY WERE IDENTIFIED AS LAMARCUS THOMAS AND ROY JENKINS. BOTH VICTIMS WERE TRANSPORTED TO AREA HOSPITALS FOR MEDICAL CARE. JENKINS LATER SUCCUMBED TO HIS INJURIES. THE CORONER RESPONDED TO THE HOSPITAL AND TOOK POSSESSION OF JENKINS BODY FOR AUTOPSY. THE NEXT OF KIN WAS NOTIFIED AND THE INVESTIGATION IS ONGOING.
