NARRATIVE

OFFICERS WERE DISPATCHED TO 2701 S ELM STREET IN REFERENCE TO A DISTURBANCE WITH A WEAPON CALL FOR SERVICE.

UPON ARRIVAL, OFFICERS WERE FLAGGED DOWN BY ZACHARY COMBS. MR. COMBS RAN TOWARD OFFICERS WITH HIS HANDS IN THE AIR AND APPEARED TO BE FRIGHTENED. OFFICERS OBSERVED A STRONG ODOR OF INTOXICANTS COMING FROM MR. COMB'S PERSON.

MR. COMBS ADVISED TWO MALE SUBJECTS PULLED A HANDGUN ON HIM AND TOOK THE LISTED PROPERTY FROM HIM AT APPROXIMATELY 1805 HOURS. MR. COMBS ADVISED HE WAS WALKING IN THE AREA OF 31ST AND ELM STREET WHEN TWO MALE SUBJECTS APPROACHED HIM. MR. COMBS ADVISED THE MALE SUBJECTS TOLD HIM TO GET AWAY FROM THE AREA. MR. COMBS ADVISED ONE SUBJECT HAD A SILVER HANDGUN AND THE OTHER HAD A MACHETE KNIFE. MR. COMBS ADVISED THE SUBJECT WITH THE HANDGUN LIFTED UP HIS SHIRT AND DISPLAYED THE HANDGUN BUT DID NOT POINT IT AT HIM. MR. COMBS ADVISED THE SUBJECT THEN STRUCK HIS LEFT HAND WITH THE HANDGUN. OFFICERS OBSERVED DISCOLORATION TO MR. COMBS LEFT HAND. MR. COMBS REFUSED MEDICAL ATTENTION. MR. COMBS ADVISED DURING THE ALTERCATION THE SUBJECT DISPLAYED THE HANDGUN AGAIN AND TOOK MR. COMBS BACKPACK, WHICH WAS ON THE GROUND AT THE TIME. INSIDE THE BACKPACK WAS AN IPAD AND GALAXY ANDROID PHONE. MR. COMBS WAS NOT ABLE TO PROVIDE OFFICERS WITH SERIAL NUMBERS.

MR. COMBS WAS ABLE TO GIVE OFFICERS A DESCRIPTION OF ONE OF THE SUBJECTS. MR. COMBS ADVISED THE SUBJECT WAS APPROXIMATELY 5'6, 130 POUNDS AND WEARING A YELLOW SHIRT. OFFICERS DID A BROADCAST OF THIS INFORMATION OVER MAIN CHANNEL.

OFFICERS CIRCULATED THE AREA OF 31ST AND ELM STREET AND OBSERVED A BLACK FEMALE, LATER IDENTIFIED AS JOANN RABB WALKING IN THE AREA. MS. RABB HAD A BALD HEAD AND COULD BE MISTAKE FOR A MALE. MS. RABB WAS WEARING A CAMOUFLAGE BACKPACK WITH A MACHETE KNIFE ATTACHED TO IT. OFFICERS STOPPED MS. RABB AND QUESTIONED HER.

MS. RABB ADVISED A WHITE MALE CAME TO THIS LOCATION AND WAS IN HER HOMELESS AREA. MS. RABB ADVISED SHE ASKED THE WHITE MALE TO LEAVE AND THE WHITE MALE DISPLAYED A SILVER HANDGUN. MS. RABB ADVISED THE WHITE MALE STATED, "GET BACK OR I'M GOING TO SHOOT YOU". MS. RABB ADVISED THE WHITE MALE DID NOT POINT THE HANDGUN AT HER. MS. RABB ADVISED THE WHITE MALE THEN LEFT THE AREA.

MS. RABB GAVE OFFICERS PERMISSION TO SEARCH HER BACKPACK AND OFFICERS DID NOT LOCATE THE LISTED PROPERTY. MS. RABB ADVISED THE INCIDENT OCCURRED APPROXIMATELY 3 HOURS BEFORE OFFICERS ARRIVAL.

OFFICERS WERE NOT ABLE TO LOCATE ANY WITNESSES TO THE INCIDENT. BOTH MR. COMBS AND MS. RABB ADVISED OF A SILVER HANDGUN, WHICH OFFICERS DID NOT LOCATE A HANDGUN ON EITHER SUBJECT. DUE TO THE NATURE OF THE STORIES AND NO WITNESSES OFFICERS RELEASED BOTH SUBJECTS. MAJOR CRIMES WAS NOTIFIED.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A THEFT. UPON ARRIVAL, CONTACT WAS MADE WITH MR. RANZI ALFAIQ AND MR. CHARLES TILLMAN, EMPLOYEES FOR THE LOCATION. MR. ALFAIQ ADVISED AN UNKNOWN BLACK MALE WALKED INTO THE LOCATION AND STOLE TWO 30 PACKS OF BUD LIGHT BEER BEFORE WALKING OUT AND GETTING INTO VEHICLE 1. MR. TILLMAN ADVISED HE CHASED AFTER THE SUSPECT AND ATTEMPTED TO GET THE MERCHANDISE BACK BUT THE SUSPECT STRUGGLED WITH MR. TILLMAN AND ALLEGEDLY HAD A FIREARM, CAUSING MR. TILLMAN TO STEP BACK. MR. ON TODAYS DATE COMMUNICATIONS RECEIVED A CALL IN REGARD TO A SHOOTING VICTIM.

UPON ARRIVAL, OFFICERS SPOKE WITH KATRINA HARRIS WHO STATED HER SON, A JUVENILE, WAS SHOT. HARRIS STATED SHE KNEW NOTHING OF THE INCIDENT OTHER THAN HER SON WAS SHOT.
