#### NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REGARDS TO A DISTURBANCE. COMMUNICATIONS ADVISED THE CALLER, ARRIBAS STATED A UNKNOWN BLACK MALE THAT WAS SQUATTING AT THIS LOCATION TOOK HIS PHONE. UPON ARRIVAL, OFFICERS MADE CONTACT WITH ARRIBAS WHO ADVISED HE WAS THE PROPERTY MANAGER.

ARRIBAS STATED HE WAS CHECKING ON AN APARTMENT THAT HAD SQUATTERS INSIDE. ARRIBAS STATED WHEN HE ENTERED THE APARTMENT, HE OBSERVED AN UNKNOWN BLACK MALE WITH BRAIDED DREADS WITH A YELLOW TIP LIVING INSIDE. ARRIBAS STATED HE TOOK HIS PHONE OUT TO BEGIN RECORDING THE MALE. ARRIBAS STATED THE MALE ATTEMPTED TO GRAB HIS PHONE TO STOP HIM FROM RECORDING AND RESULTED IN THE UNKNOWN BLACK MALE SHOVING ARRIBAS ONTO A COT THAT WAS MADE IN THE LIVING ROOM. ARRIBAS STATED THE UNKNOWN BLACK MALE RAN OUT FROM THE APARTMENT TOWARDS BOWMAN ROAD. ARRIBAS STATED HE CHASED THE UNKNOWN BLACK MALE AND LAST SAW HIM BY THE LITTLE CAESARS DOWN THE STREET.

ARRIBAS STATED THE UNKNOWN BLACK MALE HAS A NICKNAME OF "BEAR". OFFICERS CIRCULATED THE AREA AND DID NOT OBSERVE ANY SUBJECT MATCHING THE DESCRIPTION PROVIDED. MEDICAL WAS REFUSED. A BROADCAST WAS PUT OUT ON THE UNKNOWN BLACK MALE THROUGH CITY COMMUNICATIONS. ARRIBAS WAS PROVIDED AN INCIDENT NUMBER AND ADVISED TO CALL BACK IF THE UNKNOWN BLACK MALE RETURNS. 21C661 IS MVR EQUIPPED AND WAS IN USE.
