NARRATIVE

OFFICER TROTTER RESPONDED TO THE LISTED LOCATION, REGARDING A ROBBERY OF AN INDIVIDUAL. I MADE CONTACT WITH THE CALLER, MR. JIM RAY WHO STATED HE WAS ROBBED ON TODAY'S DATE AT APPROXIMATELY 12:45AM BY TWO BLACK MALES. MR. RAY STATED HE WAS WALKING THROUGH THE COMPLEX BUILDING WHEN HE NOTICED TWO BLACK MALES BY THE NAME OF "KELTON AND BRISON". MR. RAY WASN'T SURE OF EITHER ONE OF THEIR LAST NAMES OR A CURRENT LIVING ADDRESS FOR THE TWO MALE SUSPECTS. MR. RAY STATED KELTON APPROACHED HIM AND PUSHED MR. RAY AGAINST THE WALL AND DEMANDED ALL THE MONEY IN HIS POCKETS. MR. RAY STATED WHILE KELTON HELD HIM AGAINST THE WALL, BRISON WENT INSIDE MR. RAY'S PANTS POCKET AND TOOK \$621.00 CASH FROM MR. RAY. JIM RAY STATED ONCE THE TWO MALES GRABBED THE CASH, THEY TOOK OFF RUNNING THROUGH THE APARTMENT COMPLEX, HEADED IN AN UNKNOWN DIRECTION. WHILE ON SCENE, I MADE CONTACT WITH JIM RAY'S GIRLFRIEND, MS. DOMONIQUE BROWN. SHE STATED SHE RECEIVED A CALL FROM A MALE NAME, "LIL BILL (30YR OF AGE), WHO ALSO LIVES IN THE SAME COMPLEX AS MR. RAY; STATING HE KNEW JIM RAY JUST GOT ROBBED. HE STATED HE WOULD "GET BACK AT MS. BROWN IF SHE TOLD THE POLICE HE HAD ANYTHING TO DO WITH THE ROBBERY!" MS. BROWN STATED LIL' BILL IS A DRUG DEALER AND ASSOCIATES HIMSELF WITH THE TWO INDIVIDUALS WHO ROBBED JIM RAY ON TODAY'S DATE. THERE WAS NO WITNESSES ON SCENE DURING THIS TIME. OFFICERS CIRCULATED THE AREA FOR MR. KELTON AND BRISON, WITH NEGATIVE RESULTS.

OFFICERS CIRCULATED THE AREA OF CANTRELL ROAD AND UNIVERSITY AVENUE FOR A POTENTIAL CRIME SCENE WITH NEGATIVE RESULTS TO LOCATE ANY EVIDENCE. OFFICERS THEN LEARNED THAT MR. BAILEY MAY HAVE BEEN NEAR THE ORIGINAL LOCATION AT 400 N UNIVERSITY AND OFFICERS CHECKED THIS AREA AGAIN WITH NEGATIVE RESULTS.

MR. BAILEY STATED THAT HE HAD A FIREARM ON HIM AND OFFICERS DID NOT LOCATE A FIREARM IN HIS BELONGINGS. HE ADVISED THAT HE DROPPED IT BUT DID NOT KNOW WHERE.

OFFICERS STOOD-BY WHILE DETECTIVES RESPONDED AND CONDUCTED THEIR INVESTIGATION. A NORTHWEST SUPERVISOR WAS NOTIFIED OF THIS INCIDENT.

OFFICERS WERE ADVISED TO GATHER MR. BAILEY'S CLOTHING AND STORED THESE AT THE 12TH STREET STATION IN THE CRIME SCENE LOCKERS AND FILLED OUT THE APPROPRIATE PAPERWORK.

MVR AND BWC WERE IN USE.
