OFFICERS OBSERVED IN THE VIDEO, SUS1 RUNS INTO 7601 N CHICOT ROAD BY HOPPING THE FENCE. THE VIDEO SHOWS SUS1 FLEE NORTH ON CHICOT ROAD AND J3 RAN NORTHEAST INTO THE COMPLEX AFTER THE SHOTS. OFFICERS NOTIFIED SGT. SNOW AND MAJOR CRIMES WHO RESPONDED TO THE SCENE. OFFICERS OBSERVED SHELL CASINGS IN THE ROADWAY JUST WEST OF 7601 N CHICOT ROAD. OFFICERS CIRCULATED THE APARTMENT COMPLEX FOR SUS1 WITH NEGATIVE RESULTS, HOWEVER OFFICERS FOUND HIS JACKET AND BALACLAVA IN AN EMPTY DUMPSTER IN THE SOUTHEAST CORNER OF 7601 N CHICOT ROAD. OFFICERS OBSERVED SEVERAL BULLET HOLES IN 7700 N CHICOT ROAD #L103&L104. OFFICERS MADE CONTACT WITH THE RESIDENTS, FRANKIE PERKINS AND CAROLYN USSERY, BOTH ADVISED THEY WERE INSIDE WHEN THE BULLETS CAME THROUGH THEIR HOMES. MS.
