NARRATIVE

ON MARCH 12TH, 2024 AT 0238 HOURS, I RESPONDED TO 2908 SOUTH MONROE STREET FOR A SHOT SPOTTER ACTIVATION.

WHEN I ARRIVED AT THE ABOVE ADDRESS, I MADE CONTACT WITH DEMETRICE TAYLOR. TAYLOR TOLD ME HER SON, CLAUDE TAYLOR, HAD JUST LEFT THE HOME AFTER SHOOTING HIS PISTOL AT THE HOME.

WHILE SPEAKING WITH D. TAYLOR, I OBSERVED THE WINDOW ON HER PORCH WAS BROKEN AND A RIP IN THE WINDOW DRAPES. D. TAYLOR SAID THAT WAS NOT THERE BEFORE C. TAYLOR LEFT. AFTER LOOKING INSIDE THE HOME FOR THE PATH OF TRAVEL, I LOCATED A BEAN BAG WITH A SMALL RIP IN IT, LYING ON THE FLOOR. ON FURTHER OBSERVATION, I NOTICED A CHUNK OF THE WIFI ROUTER MISSING NEAR THE FLOOR AND A RIP IN THE CARPET BELOW IT. WHEN I PICKED UP THE CARPET, I LOCATED DAMAGE TO THE HARDWOOD FLOOR UNDERNEATH AND A METAL PROJECTILE LYING BESIDE THE DAMAGED HARDWOOD.

DETECTIVE PATILLO RESPONDED AND TOOK OVER THE SCENE.

OFFICERS LOCATED AN UNSPENT BULLET IN THE FLOWERBED IN THE FRONT YARD OF 2908 SOUTH MONROE STREET. THE UNSPENT BULLET AND PROJECTILE WERE RECOVERED AND ENTERED INTO EVIDENCE AT THE 12TH STREET PATROL SUBSTATION.

NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED AREA FOR THE REPORT OF A SHOT SPOTTER ACTIVATION. SHOT SPOTTER REGISTERED ONE ROUND. UPON ARRIVAL, OFFICERS WERE CIRCULATING THE AREA WHEN THEY WERE FLAGGED DOWN BY MULTIPLE SUBJECTS AT 3516 WEST 10TH STREET. OFFICERS WERE ADVISED CHRISTIAN HOWARD WAS SHOT IN THE LEG. OFFICERS PROVIDED MEDICAL ATTENTION ON SCENE UNTIL MEMS AND LRFD ARRIVED. OFFICERS OBSERVED A BLUE CHEVROLET MINI-VAN, VEHICLE 1, WITH MULTIPLE BULLET STRIKES. OFFICERS SECURED THE SCENE AND ALL VICTIMS/WITNESSES. SERGEANT HARDMAN, MAJOR CRIMES DETECTIVES, AND CSSU WERE NOTIFIED. HOWARD WAS TRANSPORTED BY MEMS TO AN AREA HOSPITAL FOR FURTHER MEDICAL CARE. THE WITNESSES WERE TRANSPORTED TO THE 12TH STREET STATION FOR FURTHER INVESTIGATION.

WHILE DETECTIVES WERE INTERVIEWING HOWARD AT THE HOSPITAL, TAYLOR HAWKINS WAS DROPPED OFF WITH A GUNSHOT WOUND. IT WAS DETERMINED THROUGH THE INVESTIGATION THAT HAWKINS WAS SHOT AT THE INCIDENT ADDRESS.

DURING THE INVESTIGATION, FRANK GARRISON, THE OWNER OF THE BLUE CHEVROLET VAN STATED HIS SON, XAVIER GARRISON, WAS ABOUT TO GO TO THE STORE IN THE VAN. XAVIER GARRISON, STATED TO OFFICERS ON SCENE THAT HE WAS EXITING THE HOUSE AT THE TIME OF THE SHOOTING. XAVIER GARRISON STATED TO OFFICERS, ON SCENE, THE REASON HE WAS NOT OUTSIDE AT THE TIME OF THE SHOOTING IS DUE TO HIM GOING INSIDE TO GET THE KEYS TO THE VAN. XAVIER GARRISON IS A CONVICTED FELON AND HAS A VALID SEARCH WAIVER ON FILE. AFTER A CONSENT SEARCH OF THE VEHICLE, A HANDGUN WAS LOCATED BY CSSU. A WARRANTS CHECK WAS CONDUCTED SHOWING XAVIER GARRISON TO HAVE A FAILURE TO PAY WARRANT (LRCD-21-682) OUT OF LITTLE ROCK CRIMINAL COURT. DUE TO XAVIER GARRISON HAVING CONSTRUCTIVE POSSESSION OF THE VAN, HE WAS CHARGED WITH POSSESSION OF FIREARMS BY CERTAIN PERSON.

AT THE 12TH STREET STATION, OFFICERS WERE ATTEMPTING TO IDENTIFY ALL VICTIMS/WITNESSES. ONE OF THE VICTIMS STATED HIS NAME WAS "ROGER CLARK" (B/M 06/30/2003). OFFICERS WERE UNABLE TO POSITIVELY IDENTIFY CLARK. OFFICERS ASKED CLARK AGAIN FOR HIS NAME AND HE AGAIN STATED "ROGER CLARK". CLARK WAS TRANSPORTED TO THE JAIL TO BE FINGERPRINTED. ONCE AT THE JAIL OFFICERS WERE ADVISED THE SUBJECTS NAME WAS RODERICK CLARK. CLARK ALSO WAS SHOWN TO HAVE A FTA WARRANT (MU-23-702) OUT OF MAUMELLE POLICE DEPARTMENT. CLARK WAS CHARGED WITH OBSTRUCTION OF GOVERNMENTAL OPERATIONS AND SERVED HIS WARRANT.

CLARK AND XAVIER GARRISON WERE TRANSPORTED TO PCRJ AND SUBSEQUENTLY CHARGED WITH THEIR WARRANTS AND ABOVE LISTED CHARGES WITHOUT INCIDENT.

THE INVESTIGATION IS ONGOING. MVR/BWC IN USE.
